The following is the signage application for a sidewalk sign for the Appalachian Mountain Club (AMC), located at 30 Exchange Street. We understand that you have regulations for distances between sidewalk signs, and we are aware that our two neighbors in the building, businesses "Something Fishy" and "Second Time Around" both utilize these signs.

We are intending to staff our office with volunteers, who will provide visitors with more information about the AMC's services – membership, outdoor activities, and our Maine Wilderness Lodges. We will likely only have volunteers a few hours each day, likely ten hours a week. We do not have a storefront, and therefore a sidewalk sign would be our only option of visibility by the public. We would like to place this sign out front of 30 Exchange only during the hours in which we have a volunteer. Therefore, the sign would not sit outside for eight hours each day, rather for a few hours each week. We believe that with this frequency, we will definitely maintain public safety and the streetscape aesthetics.








Proposed Signage



Office is on the second floor at 30 Exchange Street.




Proposed Signage
