

All three signs will be lit with small "bullet" spot lights. The large rectangular signs will be lit by two lights...one from either side. The directory will be lit by two lights...both from the top.

Sign & Awning Proposal for 425 Fore St.

<u>Signs</u>: We propose three (3) identically-sized, wooden rectangular signs which would sit flush against the building above each set of windows. The size of the signs will be approximately 12 feet long and 22 inches high (see photo #1). The lettering and the background color for each of the three signs will be unique to the individual businesses, but the scale of the lettering will be similar. Sketches and color swatches of the proposed signs for 2 tenants (exhibit #1 & #2) are enclosed. When we have a third tenant we will instruct them to use the same sign parameters, but seek approval for their particular color and design from the city.

In addition to the three main signs, we propose a square, wooden 4 foot by 4 foot sign on the east end of the building (see photo #1...marked with an X). This sign would serve as a directory for the building. The background of the sign will be painted white and the raised or engraved text will be painted dark marine blue. The sign will be similar to the following sketch:

DAll 4 signs will each be tastefully lit with 2 small spotlights on either side.
