REVOCABLE LICENSE FOR PLACEMENT OF STEP IN PUBLIC WAY

A revocable license is hereby granted to Fore Street Properties L.P. to occupy portions of land owned by the City on Wharf Street located at 410 Fore Street/15 Wharf Street, Portland, Maine, **as** shown on the attached plan, for the purpose of the placement and maintenance of a granite step on the City property, as shown on the attached plan, upon the following conditions:

- 1. Fore Street Properties L.P., its successors and assigns (hereinafter "Licensee"), shall indemnify the City of Portland, its officers, agents and employees from any **and** all claims which arise out of its use, or the use of others, of the City's Wharf Street Property in conjunction with activities related to the maintenance, of the stairway on said property.
- 2. Licensee shall procure and maintain liability insurance in an amount of not less than Four Hundred Thousand Dollars (\$400,000) combined single limit, covering claims for bodily injury, death and property damage and shall either name the City of Portland as an additional insured with respect to such coverage or shall obtain a contractual liability endorsement covering the obligations of Licensee under the terms of this license.
- **3.** This license is assignable to any owners of the building located at 408-410 Fore Street.
- **4.** This license may be revoked upon sixty (60) days written notice of the City Manager.
