In reply to the questions you raised in our conversation of yesterday, we wish to inform you that under our contract with the Benjamin Wrecking Company, Mr. Benjazin is required to brick in all voids caused by the removal of any steel, wood or other materials connecting the former Hub Furniture Company to the party wall between this Hub Furniture Company building and the West wall of the Maine Bonding Company building.

After this work is completed, we intend to remove the exposed plaster on the west wall of the Maine Bonding Company building and if necessary, to sandblast and waterproof this surface, to leave it in a presentable condition.
