- 1) All means of egress to remain accessible at all times.
- 2) Construction or installation shall comply with City Code Chapter 10.
- 3) A separate Fire Alarm Permit is required for new systems; or for work effecting more than 5 fire alarm devices; or replacement of a fire alarm panel with a different model. This review does not include approval of fire alarm system design or installation.
- 4) Fire extinguishers are required per NFPA 1.
- 5) The approved plans with the Building Department Approved stamp shall be maintained on site for inspection.

Providing firestop labels at each firestop system or device and an onsite manual containing the detail for each firestop system or device used for the project will streamline final inspection approvals.
