Appointments must be requested 48 to 72 hours in advance of the required inspection. The inspection date will need to be confirmed by this office.

- **Permits expire in 6 months. If the project is not started or ceases for 6 months.**

- **Per Section 107.3.1 of the Maine Uniform Building and Energy Code (MUBEC). One set of printed approved stamped construction documents shall be kept at the site of work and shall be open to inspection by building officials.**

<ol style="list-style-type: none"> 1) Separate permits are required for any electrical, plumbing, sprinkler, fire alarm, HVAC systems, heating appliances, including pellet/wood stoves, commercial hood exhaust systems and fuel tanks. Separate plans may need to be submitted for approval as a part of this process. 2) Special inspections are required for the anchoring of the pole and guy wires. A statement from the overseeing engineer indicating compliance is required to be submitted at the completion of this installation. 3) Periodic inspections by the Structural Engineer of Record are required. At the completion of construction, a stamped letter shall be submitted by the engineer of record verifying substantial compliance with the approved structural design and applicable test results. This is required prior to the final inspection, occupancy and a Certificate of Occupancy.
