

TOWER LEASE AGREEMENT AMMENDMENT 1

This Amendment made on December 4th, 2014, to the original agreement made on 1st day of May 2013, by and between Communications Facilities, Inc., a Maine corporation with a place of business in Falmouth, Maine, and a mailing address of P.O. Box 8784, Portland, ME 04104-8784 ("Sub-Sub-Landlord") and RedZone Wireless, a Maine Limited Liability Company with a place of business in Rockland, Maine, and a mailing address of PO Box 435, Rockland, ME 04841 ("Tenant").

WHEREAS, Sub-Landlord is the lessee of a site located at One City Center, Portland, Maine, Cumberland County, Maine; together with a tower and interior space with the dimensions of 18' by 8' (collectively "Premises");

WHEREAS, Sub-Landlord is the lessee of a 40 foot tall tower on said site ("Tower");

WHEREAS, Tenant desires to lease additional space on tower; and

NOW THEREFORE, the parties agree as follows:

1. **Modified Equipment.** Sub-Landlord grants Tenant the non-exclusive use of said site, building and Tower (collectively the "Premises"), solely for the purpose of Tenant's installation, operation, and maintenance of the equipment modified and described in Exhibit A (collectively "Equipment").

2. **Modified Tower/Site Location.** Sub-Landlord shall provide space on the on the Tower site for the installation of Six (6) panel antennae as modified described in Exhibit B.

3. **Term.** All terms of original lease dated May 1, 2013 remain in full effect, except as noted within this amendment.

4. **Modified Rental.** Commencing Jan 1st, 2015, Tenant shall pay Sub-Landlord a monthly rental of \$1,800 during the first eleven (11) months of the Initial Term, with the first payment due and payable on Jan 1st, 2015 and subsequent payments due and payable on the first day of each month thereafter.

Starting Year two: monthly rental shall be \$1,900,

Starting Year three: monthly rent shall be \$2,000,

Starting Year four: monthly rent shall be \$2,100.

Starting on Year five and each year thereafter for the full term of this Agreement, monthly rental shall be increased by 5% from the preceding year.

If the Ubiquiti Airmax Titanium Sector AM-V2G-Ti is removed by the Tenant
Written notice is provided to the Sub-Landlord, monthly rent will be reduced by \$400.00.

6. **Modified Electricity.** Sub-Landlord will procure and pay for normal electricity usage



for the operation of Tenant's Equipment; provided, however, that Sub-Landlord will not be held liable to Tenant for electrical deficiencies resulting from acts of God, acts or omissions of the public utility, or any other cause beyond the control of Sub-Landlord. Tenant shall be limited to less than 30 amps of 120VAC electrical service as long as it is available.

18. **Amendment.** No revision of this Agreement shall be valid unless made in writing and signed by Sub-Landlord and Tenant. Sub-Landlord and Tenant have Amended this agreement herein on Dec 4th, 2014.


