RB Allen has submitted a plan to upgrade the remaining floors to addressable at 1 city center.

During a recent annual inspection it was discovered that a few of the devices on these floors have begun to fail. One of these devices is associated with elevator recall.

We attempted to service the existing devices but were not successful.

The wiring to these devices for elevator recall is compromised and it is a very long wire run.

We would like to start the upgrade of these floors immediately next week when the equipment is available. When these devices are upgraded to addressable the elevator recall is greatly simplified with an addressable relay directly at the controller on the 1<sup>st</sup> floor.

Please let me know if you have had a chance to review our submittal Please let me know if you have any questions or concerns on the design layout. Please let me know if we can have your permission to move forward.
