# SIDEWALK EASEMENT TO THE CITY OF PORTLAND

KNOW ALL PERSONS BY THESE PRESENTS that THE SALVATION ARMY, a New York corporation with a mailing address of 440 West Nyack Road, West Nyack, New York 10994, (hereinafter, "GRANTOR), for one dollar and other good and valuable consideration paid by the CITY OF PORTLAND, a body politic and corporate with a mailing address of 389 Congress Street, Portland, Maine 04101 (hereinafter "GRANTEE"), does hereby grant to the said CITY OF PORTLAND the perpetual easement and rights described below on the land described below.

The purpose of said easement is to grant GRANTEE the right, but not the obligation, to construct, maintain, repair and replace a sidewalk in, on, under and over the portions of that certain parcel of land of the Grantor as described in **Exhibit A**, attached hereto and made a part hereof (the "Easement Area") and as depicted on **Exhibit B** attached hereto and made a part hereof, said sidewalk to be used by the public for pedestrian, bicycle and similar non-motorized (other than wheelchair and emergency vehicles and snow removal equipment, which shall be permitted) pedestrian recreational uses, subject, however, to such rules or ordinances that Grantee may adopt from time to time in the interests of public safety. Notwithstanding anything to the contrary in this easement, it shall be the responsibility of the GRANTOR, and not the GRANTEE, to remove snow and ice from said sidewalk and to otherwise comply with all laws, rules, regulations, and ordinances governing the removal of snow and ice.

GRANTOR further covenants and agrees for itself, its successors and assigns, that the land that lies in the Easement Area shall, except for the construction, maintenance, repair, or replacement of the sidewalk and any appurtenances by GRANTEE, its successors and assigns, as provided and permitted herein, be maintained as a sidewalk for the uses set forth and described herein and GRANTOR shall not use or permit any use that would be contrary to such condition.

To have and to hold the said Easement and all rights granted hereunder to the said GRANTEE and its successors and assigns forever.

#### Metes and Bounds Description

#### Sidewalk Easement along Lancaster Street and Preble Street From The Salvation Army to City of Portland

A certain lot or parcel of land situated along the southerly side of Lancaster Street and the southwesterly side of Preble Street in the City of Portland, County of Cumberland, and State of Maine, more particularly bounded and described as follows:

Beginning at the westerly corner of land of The Salvation Army, at the intersection of the southerly sideline of Lancaster Street and the easterly sideline of Alder Street, at a 5/8" rebar with cap marked 2433, to be set;

Thence N 72° 42' 52" E along the southerly sideline of said Lancaster Street, a distance of One Hundred Ten and fifty-five hundredths (110.55) feet to a 5/8" rebar with cap marked 2433, to be set at the intersection of the southerly sideline of Lancaster Street and the southwesterly sideline of Preble Street;

Thence S 42° 31' 32" E along the southwesterly sideline of said Preble Street, a distance of Thirty-Six and seventy-five hundredths (36.75) feet to a point;

Thence S 47° 28' 28" W through land of the The Salvation Army, a distance of One and zero hundredths (1.00) feet to a point;

Thence N  $42^{\circ}$  31' 32" W through land of the The Salvation Army, a distance of Thirty-Six and twelve hundredths (36.12) feet to a point;

Thence S 72° 42′ 52″ W through land of the The Salvation Army, a distance of One Hundred Nine and eighty-two hundredths (109.82) feet to a point at the easterly sideline of Alder Street;

Thence N 22°32'53" W along the easterly sideline of said Alder Street a distance of One and zero hundredths (1.00) feet to the point of beginning.

The above described parcel contains 146 square feet.

All bearings noted are referenced to grid north per plan entitled: "Partial Boundary Survey of Land of The Salvation Army" prepared by Jones Associates Inc. dated July 6, 2016, Revised October 6, 2016.

Meaning and intending to convey an easement upon a portion of the premises conveyed to The Salvation Army by Warranty Deed from Evan P. Vamvakias (A.K.A. Evangelos D. Vamvakias) by a deed dated March 29, 1962, recorded in the Cumberland County Registry of Deeds in Book 2663, Page 494; and by deed from Thomas Cardente dated November 3, 1975 recorded in said Registry of Deeds in Book 3794, Page 117; and by deed from Bayside I, LLC dated September 9, 2010, recorded in said Registry of Deeds in Book 28063, Page 194.
