- 2) Any cutting and welding done will require a Hot Work Permit from Fire Department.
- 3) Shall meet the requirements of 2009 NFPA 1 Fire Code.
- 4) NFPA 1 Fire Code Per 1.14.4 Review and approval by the AHJ shall not relieve the applicant of the responsibility of compliance with this Code.
- 5) Hood suppression system shall comply with NFPA 17A, 96, and UL 300. Activation of the suppression system shall activate the fire alarm system if available.
