With the issuance of this permit, the owner, builder or their designee is required to provide adequate notice to the City of Portland Inspections Division for the inspections listed below. Appointments must be requested 48 to 72 hours in advance. The inspection date will need to be confirmed by this office.

- **Please read the conditions of approval that are attached to this permit.**
- **Permits expire in 6 months if the project is not started or ceases for 6 months.**
- **If the inspection requirements below are not followed, then additional fees may be incurred due to the issuance of a "Stop Work Order" and subsequent release to continue.**
- **Per Section 107.3.1 of the Maine Uniform Building and Energy Code (MUBEC), one set of printed approved stamped construction documents will be kept at the site of work and open to inspection by building officials.**

<b>Conditions:</b>				
1) Kitchen area needs to have the fire sprinkler and fire alarm systems extended to and install in that room.				
2) A separate City of Portland Commercial Hood / Exhaust Permit is required for new kitchen exhaust systems.				
A separate City of Portland Non-Water Based Fire Suppression System Permit is required for new kitchen fire suppression systems.				
3) Portable fire extinguishers shall be installed, inspected and maintained in accordance with NFPA 10, Standard for Portable Fire Extinguishers and 2009 NFPA 101, Chapter 9.7.4 Manual Extinguishing Equipment.				
A wet chemical class K fire extinguisher is needed within 30' of travel distance for the kitchen hood system.				
4) All construction shall comply with City Code, Chapter 10.				
All construction shall comply with 2009 NFPA 101, Chapter # 43				
All construction shall comply with 2009 NFPA 1, Fire Code. Review and approval by the AHJ shall not relieve the applicant of the responsibility of compliance with this Code (Chapter 1.14.4).
