Regarding this, it sounds like they actually only want one wall sign, so I told them as long as they meet the square footage limitation for that zone, there shouldn't be a problem.

However, they do want to replace the projecting banners as well - but go down to three instead of the current five. I think the question is whether they have to apply for their own waiver through planning for these additional signs, or if they automatically have the right to replace to the same dimensions since they've been approved by us once.

Hi Barbara,

Question for you - it looks like Apothecary by Design/Perx-U-Up Cafe at 84 Marginal Way will be changed to a new pharmacy soon. The previous business got two sign permits (one for the pharmacy, one for the cafe) with the approval of Rick Knowland. This zone normally allows only one sign per tenant; I'm not sure if we allowed two because the were two different major activities. I can't find any information on the G-drive explaining the rationale. Anyway, the new company wants to replace these with their own signs - same sign at each entrance (see attached plan). Is this likely to be OK? Do they need to apply for their own sign waiver to have two signs? Also, the previous business got a waiver from Jean for six projecting banners. If the new business wants to replace these banners with their own signage, will they need to apply for their own sign waiver?
