I am wondering what would be required for us to slightly revise our fence plan, per the attached. This simplifies ADA access for the YMCA and still secures the back trash area with fewer moving parts. We would use the same described fencing that was approved- the only difference from the street view would be that the gate would be pushed back so that the YMCA always has access to their ADA entry door without another level of controls. Is this acceptable, or who do I need to run it by?

Hi Christian,

Thanks for the quick response. I just tried calling, and will summarize my explanation below.

The fence at the end of the alley would be added to create a safe and secure area for residents to access the trash bins and for the YMCA users to egress. The existing condition at this location is a retaining wall with a big drop-off from the alley elevation down to the elevation of YMCA egress and 415's trash area- this has become a place for people to do elicit activities, which I would prefer to deter with the added fence. The fence would be visible from Cumberland Avenue, but it is at the far end of the alley in the shadows, so would by no means catch your eye from the street. There are usually also cars parked between the street and this location.

For the rear area described above I would prefer to use a chainlink fence, so as not to further create an area of shelter form wind and view. The fencing could be black to help disappear, or whatever you think is best.
