Before concrete for foundation is placed, approvals from the Development Review Coordinator and Inspection Services must be obtained. It is strongly recommended that a registered land surveyor check all foundation forms before concrete is placed. This is done to verify that the proper setbacks are maintained. The Sprinkler System shall maintained to NFPA #13 Standard.
All exit signs, lights, and means of egress lighting shall be done in accordance with Chapter 10 Section & Subsections 1023. & 1024. Of the City's building code. (The BOCA National Building Code/1996)

certification to the Division of Inspection Services.
Ventilation shall meet the requirements of Chapter 12 Sections 1210. Of the City's Building Code.
All electrical, plumbing and HVAC permits must be obtained by a Master Licensed holders of their trade.
All requirements must be met before a final Certificate of Occupancy is issued.
All building elements shall meet the fastening schedule as per Table 2305.2 of the City's Building Code. (The BOCA National Building Code/1996).
Ventilation of spaces within a building shall be done in accordance with the City's Mechanical Code (The BOCA National Mechanical Code/1993).


