Memorandum from Department of Building Inspection, Portland, Maine Erection of projecting sign for Regal Shoe Co. at 555 Congress Street by United Neon

July 19, 1951

Permit to include steel and aluminum in combination is issued subject to the condition that at all places where steel or iron and aluminum would otherwise be in direct contact, both surfaces-steel or iron and aluminum-will be conted with bituminous paint, including bolts and unshers, or treated in equivalent fashion to prevent corrotion from taking place between the two metals.

The sketch filed with the application for the permit leaves some doubt as to whether or not the location of the proposed or braces or guys would not interfere with fire Department access to the window at the fire leaves. Such interference with access by the fire Department in case of fire should be resided for the benefit of efficient action by the fire Department and for the benefit of the owner of the building in case of fire in it.

Should substantial change in location of the sign or it guys or bracing become necessary, installer should first apply for anendment to the permit now issued and with the application file a revised plan showing the true location.
