Your application to rake interior renovations (Change of Use) has been reviewed and a permit is herewith issued subject to the following requirements: This permit does not preclude the applicant from meeting applicants state and Federal laws.

No Certificate of Occupancy can be issued until all requirements of this latter are met.

- 1. A first alarm system shall be provided.
- 2. Emergancy lighting shall be provided.
- 3. A fire alarm acceptance report shall be submitted to the Portland Fire Department.
- Any sprinkler work over 20 heads or installation of more than 6 new sprinkler heads requires State Fire Marshal approval.
 5. Portable fire extinguishers shall be presided in second secon
- 5. Portable fire extinguichers shall be provided in accordance with NFPA 10.
- 6 Area of refuge complying with Section 5-2.12 of the Life Safety Code shall be provided.
- 7. The builder of a facility to which Section 459%-C of the Maine State Human Rights Act, Title : MRSA refers, shall obtain a certification from a design professional that the plans of the facility most the standards of construction required by this section. Prior to commencing construction of the facility, the builder shall submit the certification to the division of Inspection Services.
- 3. All exit signs, lights and means of egress lighting shall be done in accordance with Chapter 10, section & subsections 1023. & 1024.0 of the City's building code. (The BOCA National Piilding Code/1993)
