
FLOORING NOTES

- 1.) AT LOCATIONS OF EXISTING VCT INDICATED TO BE REMOVED ON CONCRETE SUBSTRATE, MECHANICALLY REMOVE TILE AND ALL ADHESIVE MATERIALS DOWN TO CONCRETE BASE UTILIZE DUSTLESS MACHINE.
-) GRIND CONCRETE HIGH POINTS AND RIDGES AS REQUIRED TO MINIMIZE FLOOR UNDULATIONS
- 3.) APPLY SELF LEVELING MATERIAL TO CLEAN CONCRETE SURFACE (MAPEI ULTRAPAN M20 PLUS) TO ENTIRE FLOOR SURFACE TO PROVIDE
- AT DOOR THRESHOLDS TO ROOMS WITH CARPET TILE ADJACENT TO NEW SELF LEVELED FLOORS, REMOVE FIRST COURSE OF CARPET TILE FEATHER (ARDEX FEATHERING MATERIAL) FROM SELF LEVELING INTO ROOM AND REINSTALL CARPET TILE, INSTALL NEW VINYL THRESHOLDS
- AL LOCATIONS OF EXISTING VCT INDICATED TO BE REMOVED ON WOOD SUBSTRATE, REMOVE TILE AND ADHESIVES, REPLACE AND REPAIR ANY DAMAGED SUBFLOOR, SKIM UNEVEN SURFACES WITH SELF LEVELING COMPOUND, INSTALL NEW 1/4" LAYER OF PLYWOOD, PREP FOR NEW VCT FLOOR TILE
- .) PROVIDE NEW TRANSITIONS AT ALL DOORWAY LOCATIONS OF NEW FLOORING AND EXISTING FLOORING.



 AND ONE 12" WIRE SHELF ABOVE THE ROD ALONG THE WALL OPPOSITE THE DOOR UNLESS

- 5 PROVIDE APPROPRIATE BLOCKING IN WALLS OF ALL BATHROOMS BEHIND FIXTURES,
- PARTITIONS AND ACCESSORIES. PROVIDE BLOCKING FOR GRAB BARS IN WALLS OF BATHROOMS
- 6 PROVIDE APPROPRIATE BLOCKING IN WALLS FOR DOOR STOPS
 7 BOTTOM EDGE OF GWB ON WALL SURFACES TO BE HELD UP 1/2" FROM CONCRETE FLOOR

DIVISION 9 – SIGNAGE

0.1<u>Interior Signage</u> – All rooms throughout the facility shall be provided with a sign. Use the building standards for guidance if appropriate. Coordinate the signage color with the interior color scheme. Specify a sign that allows for room name change. Signage must be on GSA schedule.

A.Individual signs should be no larger than 8" x 8" and attached to the adjacent wall, not on the door, unless noted otherwise on the Design Intent Drawings.

A.Signage must be firmly anchored to the walls or on sidelights with blank back panels. Include fire exit plans in the facility signage package. Placement of the signs must be consistent throughout the facility.

A.Systems Furniture workstations do not require a sign. Each MEPS Section also requires signage at entry and exit doors.

A.Provide and install the following sign in a conspicuous location near the primary entrance:

ATTENTION ALL PERSONNEL AND VISITORS

IT IS A FEDERAL CRIME TO KNOWINGLY POSSESS OR CAUSE TO BE PRESENT, A FIREARM OR OTHER DANGEROUS WEAPON IN THIS FACILITY. THE LAWFUL PERFORMANCE OF OFFICIAL DUTIES AUTHORIZED BY LAW IS EXEMPT. VIOLATORS WILL BE PROSECUTED TO THE FULLEST EXTENT OF THE LAW.

0.1<u>Exterior Signage</u> – Locate one exterior sign on the address side of the building. The sign shall be on a monument, lit to 15 foot-candles with photocell control. If the building has more than one tenant and an exterior sign is not allowed, provide a sign at the main entrance door of the MEPS space. The exterior sign is to read "MILITARY ENTRANCE PROCESSING STATION" with the USMEPCOM Logo.
