- **Permits expire in 6 months if the project is not started or ceases for 6 months.**
- **If the inspection requirements below are not followed, then additional fees may be incurred due to the issuance of a "Stop Work Order" and subsequent release to continue.**
- **Per Section 107.3.1 of the Maine Uniform Building and Energy Code (MUBEC), one set of printed approved stamped construction documents will be kept at the site of work and open to inspection by building officials.**

1) This permit is being issued with the condition that the banner is temporary. It will be installed for the fall campaign for the United Way and must be removed as soon as the campaign ends.				
2) This is the eighth year that the United Way Campaign has installed temporary banners. Since the proposed banner exceeds the allowable square footage of a temporary banner an exception has been granted by the Planning Division under section 14-368.5(g) to allow the banner "to advertise a community wide campaign supporting a significant number of nonprofits within the region."
