For the large metal sign hanging off the front façade of the Fore St building, a pre-existing sign bracket will be utilized to support the sign. All holes and fasteners will correspond to the pre-approved sign-hanging device on this side of the building.

The smaller sign will be fastened to the wall on the right hand side of the building. This sign will be hung with 3/8" stainless steel bolts fastened with AC100 concrete/mortar epoxy within drilled holes created by DSO.




