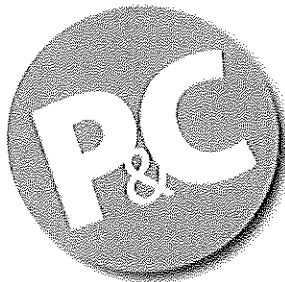
Hi Bevin,
