ORDERED, that Thursday, June 24, 2010 through Saturday, June 26, 2010, from 11:00 a.m. - 10:00 p.m., is hereby declared "Greek Heritage Festival" and the City Manager is hereby authorized pursuant to §25-27 of the Portland City Code to grant permits to the Holy Trinity Greek Orthodox Church ("Church") for said Festival, including but not limited to, the following activity:

> The Church is authorized to locate tent stakes on the right-hand side of Pleasant Street during the period of the Festival, provided that the Church shall be solely responsible for filling in the stake holes at the close of the Festival, said work to be done to the satisfaction of the City; said tent may be erected on Wednesday, June 23 and will be taken down on Sunday, June 27;

- **BE IT FURTHER ORDERED**, that the Church shall defend, indemnify and hold harmless the City of Portland, its officers and employees, from and against all claims arising out of or resulting from the parade and festival activities and/or use of City streets and property for said parade and festival activities, and shall procure and maintain public liability insurance in the minimum amount of \$400,000 combined single limit for personal or bodily injury, death or property damage and covering the obligation of indemnification hereunder. The Church shall provide the City with a certificate showing evidence of such insurance and showing the City as an additional insured on said insurance;
- **BE 1T FURTHER ORDERED**, alcoholic beverages shall not be sold on the streets or public property of said area during said Festival;
- **BE IT FURTHER ORDERED**, that alcohol may be served only in a roped off area of the parking lot between the church and the parish hall
- **BE 1T FURTHER ORDERED**, that Festival areas will be closed to street vendors pursuant to §19-17 of the Portland City Code and the City Manager is authorized to issue such other temporary licenses for the Festival, including temporary food service licenses, as may be required by the Portland City Code, provided that all applicable requirements of the Code have been met.




