I am in the process of reviewing your permit application for a seasonal enclosure at the above-referenced address. I wanted to contact you to let you know that the enclosure would not meet the City's interpretation of a "temporary tent", and therefore this application cannot qualify for the Fast-Track process. We will try to complete the additional reviews as quickly as possible. The application will need to be reviewed for code compliance, so I am requesting that you or your builder provide some additional construction details so we may move forward. Specifically, we need a manufacturer's spec sheet on the clear polycarbonate plastic sheeting, and also details on how the framing will be secured/fastened in the doorway. This information can be e-mailed directly to me, please send attachments in PDF format.

Thank you for your help, and please let me know if you have any questions about what we are seeking.
