Dear Sir,

The dwelling reportedly owned by you at 68 Pleasant St. is in direct violation of the Health and Plumbing Codes of the City of Portland.

This is in reference to the open and direct discharge of sewerage from a 3" PVC pipe sticking thru the cellar window in the basement at the rear of the building. It is discharging its waste openly and directly upon the surface of the ground and running down upon the property of others.

You are perhaps unaware of this situation and it may be something that your tenants have done without your permission. However, as owner, you are fully responsible for this matter and it must be corrected at once.

The Housing Inspection Division of the Health Dept. will again make an inspection of this property 10 days after the date of this letter for compliance before legal action is taken.
