

Dear Ms. Schmuckal:

Tracy St. Pierre and I are requesting a permit to allow us the use of our residence at 50 Maple Street for a home occupation. We intend to sell dog toys via the Internet and telephone. Please visit our Web site to see our product (www.HIQChallenge.com). We plan to use a fulfillment house to actually receive and ship the orders we receive. Below is an explanation of how we meet the demands of the Portland Zoning Ordinance.

Section 14-410 Part a

- 1. Our home occupation will occupy approximately 296 square feet (17%) of floor area of the residence.
- 2. Goods will neither be stored outside the premises or viewable from outside.
- 3. Goods will not be stored outside the areas mentioned in part 1 above.
- 4. We may have one non-illuminated sign, but it will not exceed 2 square feet and not project more than one foot from the building.
- 5. There will be no exterior alterations to the residence.
- 6. Meetings in our home will be very rare. If we have a meeting set up, the parties can park in our driveway.
- 7. We will not be making any offensive noise, smoke, or other objectionable effects.
- 8. We have no nonresident employees.
- 9. We will rarely have visitors.
- 10. We will store no vehicles over 6,000 pounds for this occupation.

Section 14-410 Part b

We fall under the sales persons category and will not have anyone physically walking into the residence and buying anything. The majority of sales will be online, with a few happening via telephone.

This home occupation is an incidental use of our residence and will not impact the residential character of our block. Attached are floor plans of the dwelling, with the office spaces identified. We own this building. Thank you for your help in this matter.
