
- 1. ALL LIGHT DIMMERS TO BE GANGED AND STACKED TOGETHER AS REQUIRED. DIMMERS SHALL BE MOUNTED 3'-6" AFF TO THE CENTERLINE UNLESS NOTED OTHERWISE.
- 2. ALL DIMMERS SHALL BE LUTRON "MAESTRO C-L SERIES". DIMMERS SHALL BE WHITE.
- 3. OPEN AREA LIGHTING SHALL BE CONTROLLED BY CEILING MOUNTED MOTION SENSORS AS MANUFACTURED BY LUTROM, MODEL "LOS-CDT-1000-WH". PROVIDE NECESSARY POWER PACK AND WALL MOUNTED LOW VOLTAGE OVER-RIDE SWITCH AT AREA ENTRANCE.
- 4. INSTALL ALL LIGHT FIXTURES IN ACCORDANCE WITH THE ARCHITECTURAL REFLECTED CEILING PLAN.


