Dear Mr. Tamaki:

I am in receipt of the letter you submitted to this office dated May 10, 2010 from Prock Marine Company. The proposed work on the pier includes the removal of fifteen (15) existing fender piles to be replaced in kind with 12-3-6 oak fender piles, and to re-bolt four (4) existing fender piles. They will also remove and replace forty four (44) feet of 6"x 6" timber curb.

I spoke with Stephen Durrell of Prock Marine on your phone while in this office and he confirmed that the fender piles do not provide structural support for the pier; they flank the pier as a protection from ships while berthing. The timber curb is to protect motorized equipment from falling off the pier.

I have confirmed with the director of this department that the work proposed on the letter dated May 10, 2010 from Prock Marine Company does not require a permit from this office.
