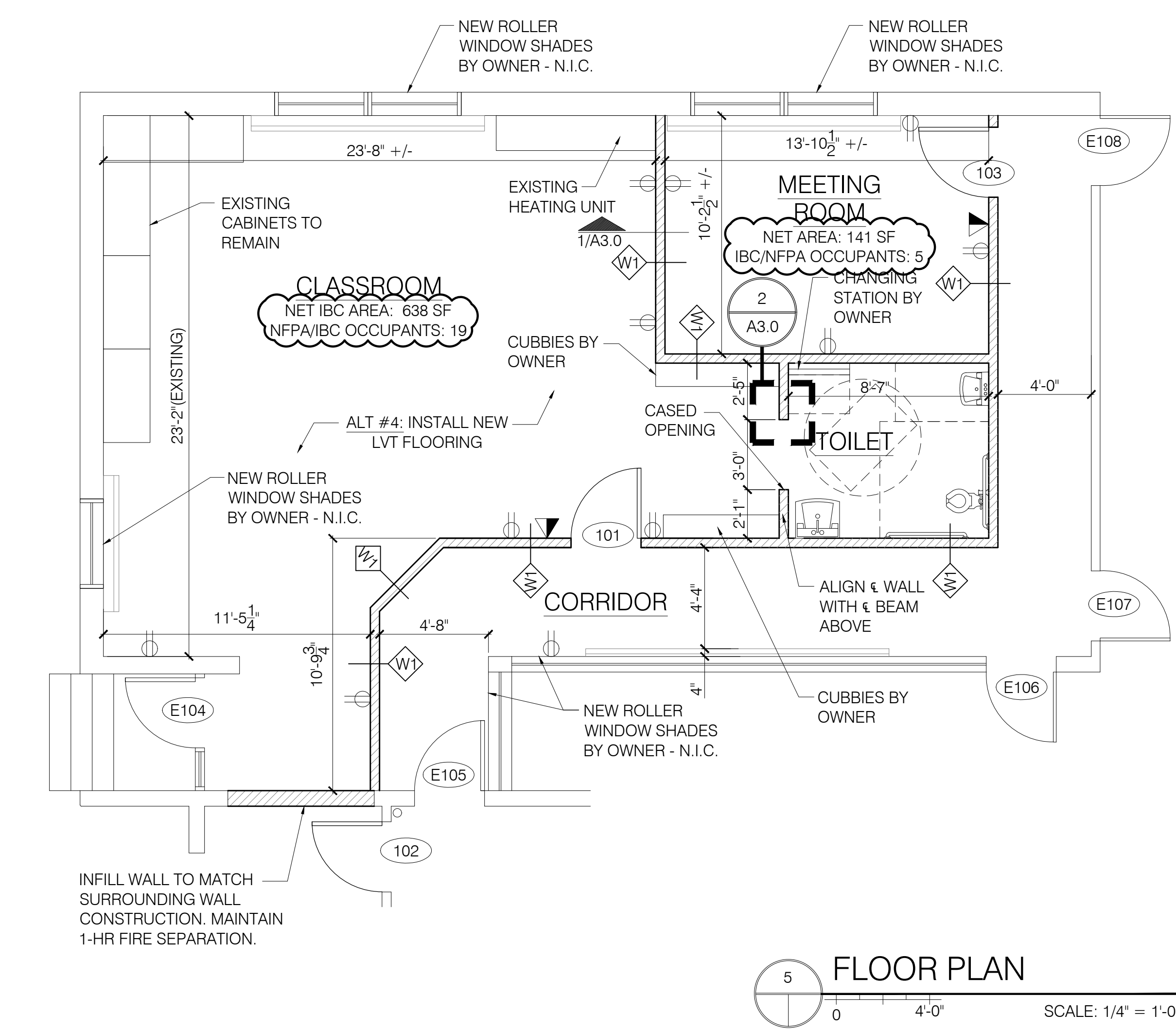
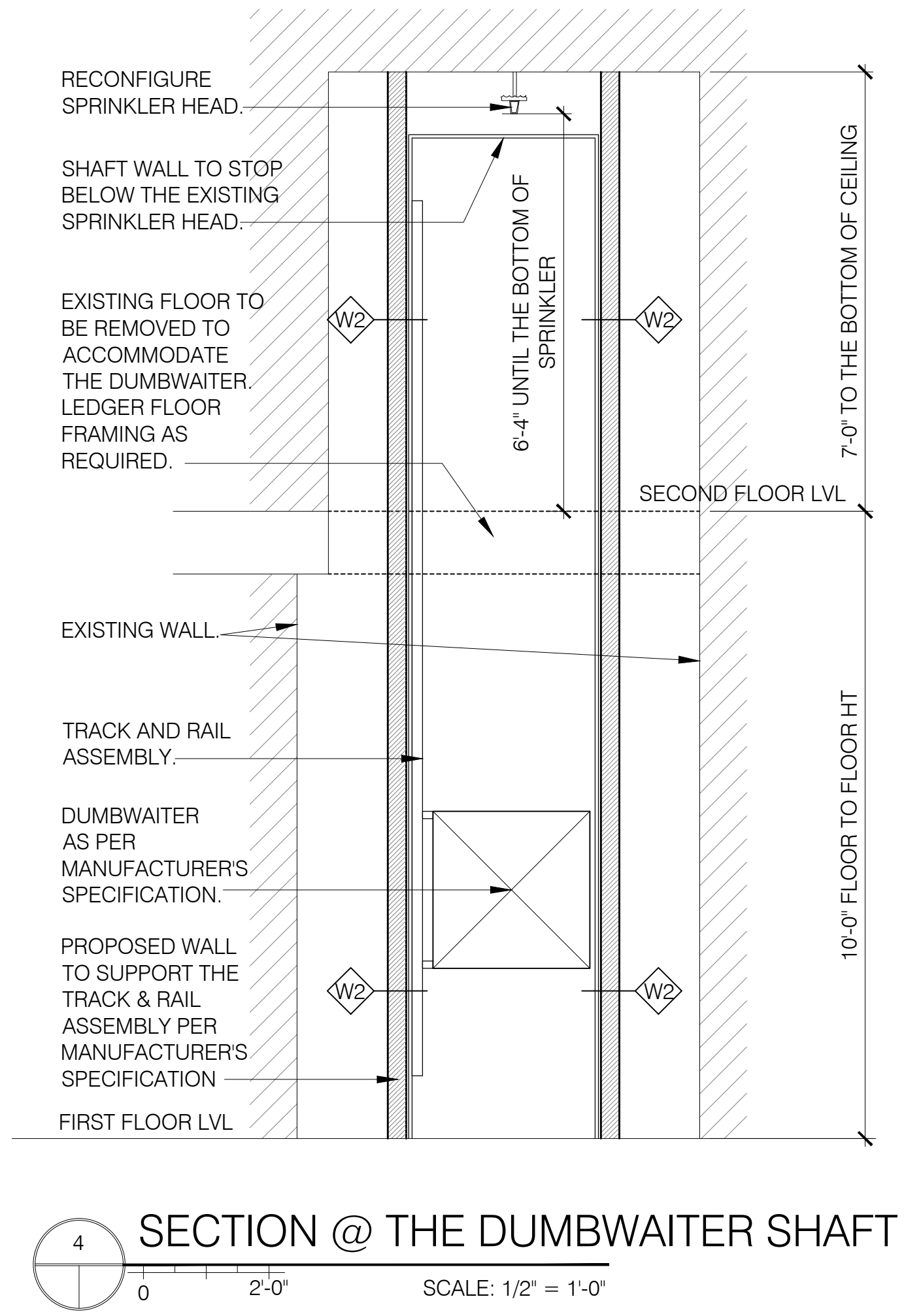


- NOTES:
1. PROPOSED WALL TO SUPPORT THE DUMBWAITER SHAFT.
 2. REMOVE EXISTING WALL TO PROVIDE OPENING FOR THE LIFT AS REQUIRED BY THE MANUFACTURER.
 3. DUMBWAITER/GOODS LIFT AS PER MANUFACTURERS SPECIFICATION.
 4. INSTALL DOOR PROVIDED BY DUMBWAITER MANUFACTURER.
 5. ALTERNATIVE #1: DUMBWAITER AND SHAFT NOT IN SCOPE.

- NOTES:
1. BOTTOM OF 1'-0"x2'-0" TRANSOM WINDOWS TO MATCH WITH THE EXISTING DROP SOFFIT.
 2. CEILING HEIGHTS TO MATCH WITH THE EXISTING ONES; MATERIAL AND FINISH FOR THE PROPOSED DROP CEILING SOFFIT TO MATCH WITH THE EXISTING ONES; JOINTS TO BE SEAMLESS.
 3. SPRINKLER HEAD TO BE REPOSITIONED AS REQUIRED PER CODE - TYPICAL.
 4. PROPOSED WALLS TO STOP AT THE BOTTOM OF ITS RESPECTIVE CEILING.
 5. INSTALL NEW TRANSFER AIR GRILLE, AND MODIFY AND REROUTE DUCTWORK AS REQUIRED TO MAINTAIN PURPOSE AND FUNCTION.
 6. CORE DRILL EXTERIOR WALL MASONRY AND INSTALL NEW EXHAUST HOOD AND ASSOCIATED DUCTWORK. PROPERLY SEAL AND FLASH PENETRATION FOR A WEATHERTIGHT INSTALLATION.

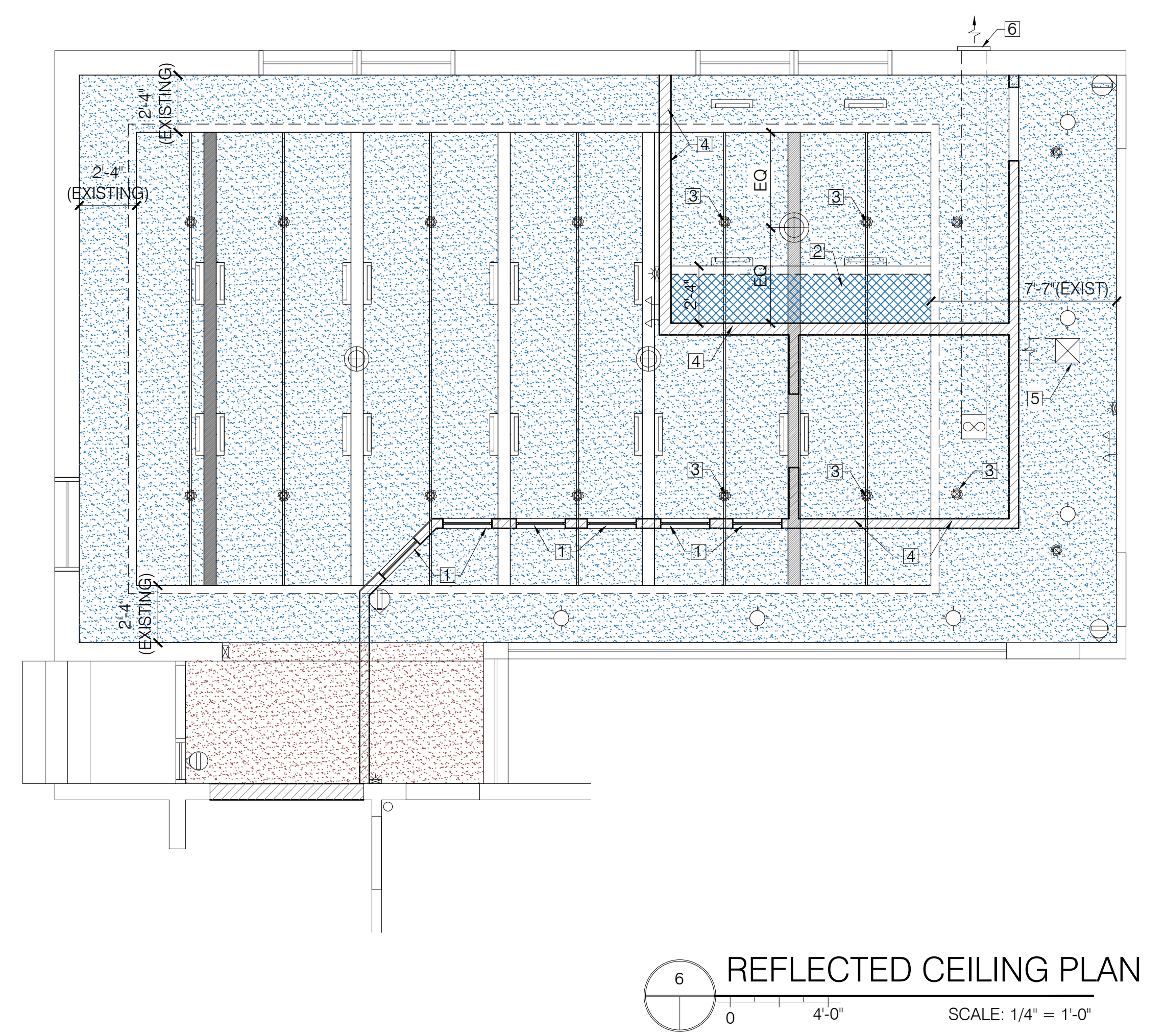
