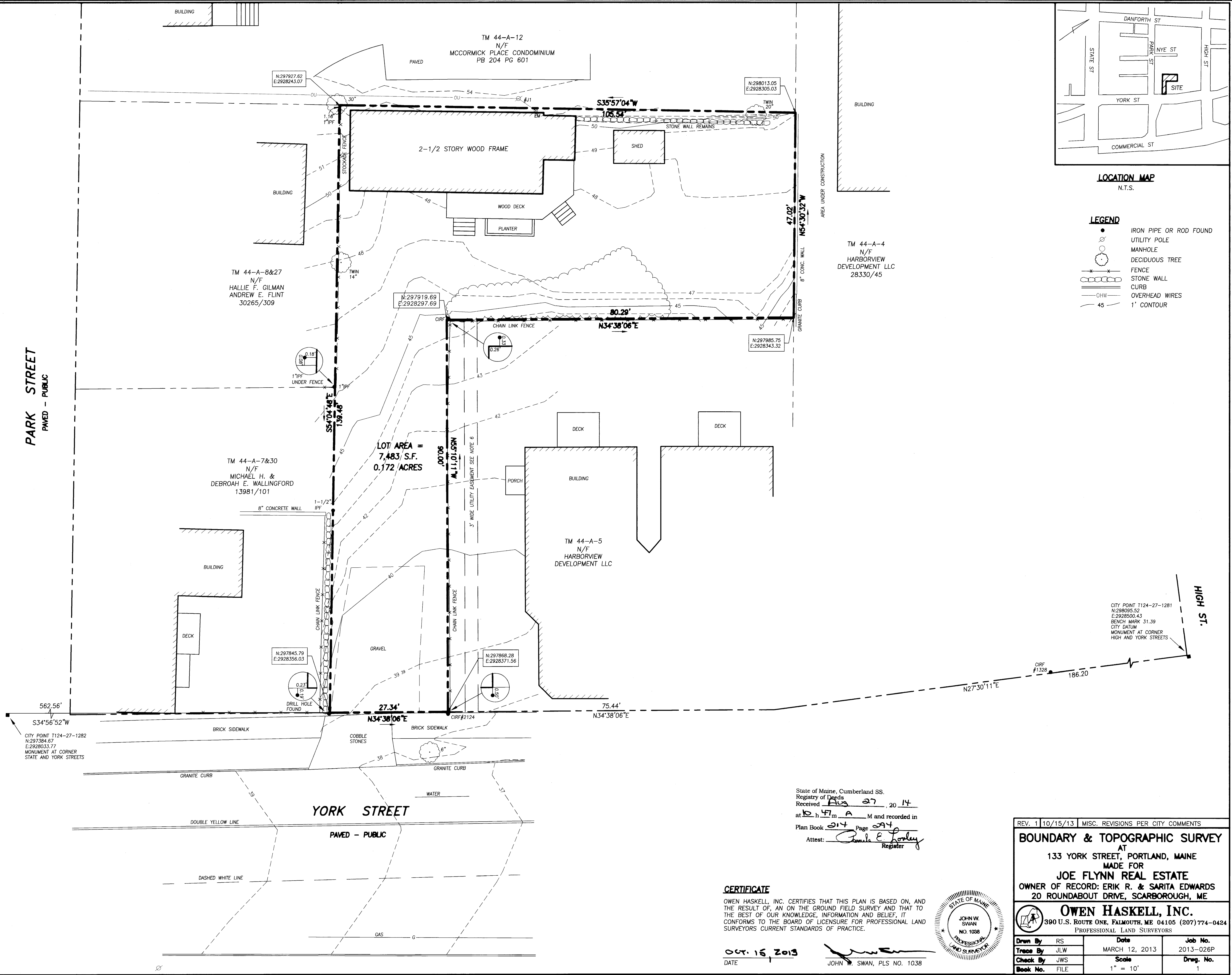


LOCATION MAP

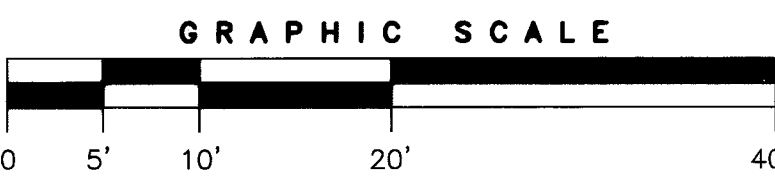

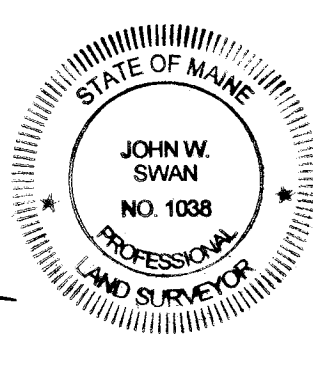
