> Apologies for the delay in my reply. We did a bit of investigating and
> collaboration on the fence so we could let you know what would be an
> acceptable solution to our residents.
>

> We believe the best method of construction would be for you to build
> similarly styled fence panels on your side of the property line and use our
> posts to attach them. The current mounting hardware would need to be
> replaced with longer bolts. You could then choose a harmonizing
> material/color that would just show through our fence slots. This would
> still allow us to grow vines on the fence for greenery, and (as you
> suggested) you can plant the Hydrangeas on your side .
