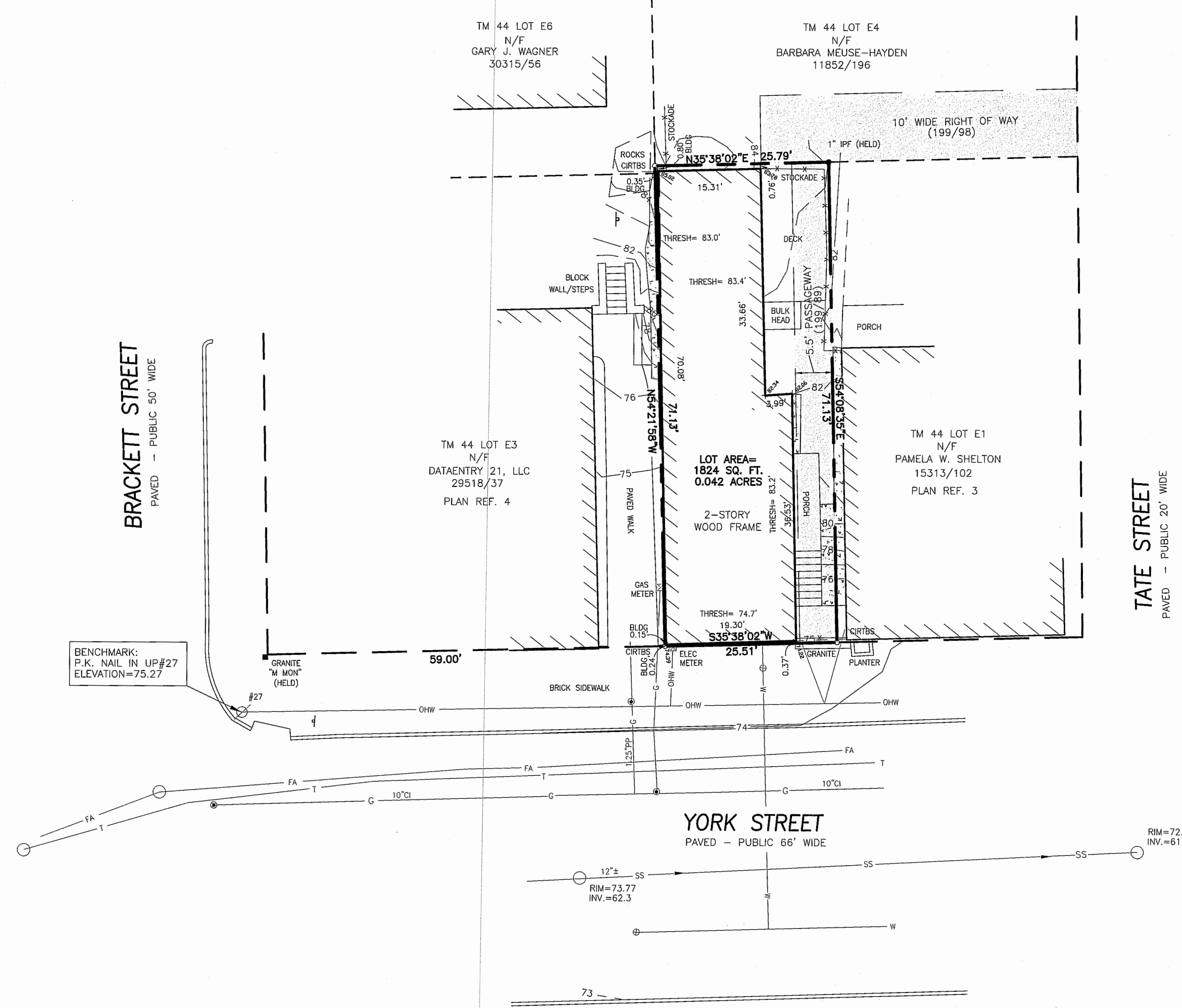


LOCATION MAP

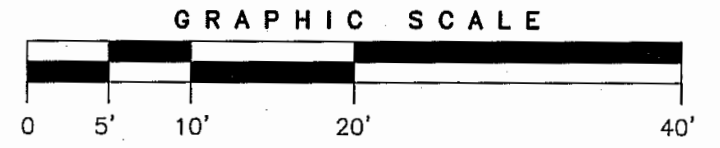

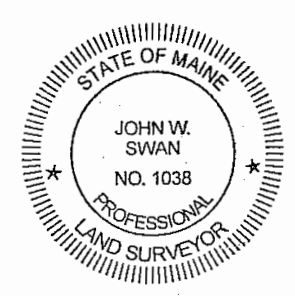

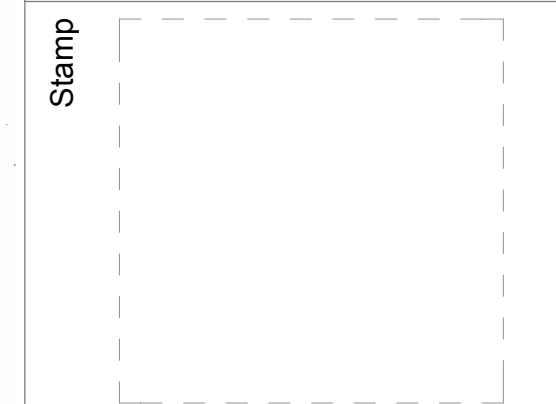
