Dear Members of the Zoning Board of Appeals:

As a forty year resident of the West End, I have been following the zoning variances being requested for 227-229 York Street.

After your last consideration of this issue, when the requested parking variance was denied (for good reason in my view), I am shocked that this matter is again before the Board, with another parking variance being requested.

What is additionally troubling is the deceitful behavior of the apparent building owner's husband, Tom Landry, in failing to acknowledge his personal interest in the property. In the submission before you, he is representing himself as the "Manager". As the husband of the building owner and as a professional realtor and investor, he is the one who should be held accountable to affirmatively and persuasively demonstrate that the property acquired several years ago cannot support another permitted use without a zoning waiver. I do not believe this can be done.

In addition to the potential huge impact of another side-by-side restaurant on the densely-packed residential neighborhood, something stinks about this whole proposal...

There is no "right" to a zoning waiver, especially given the deceitful nature of the parties and when the standards for a waiver are not met.
I urge you to reject this request.
