<ol style="list-style-type: none"> <li>1) Fire department connection type and location shall be approved by the AHJ.</li> <li>2) Sprinkler supervisory systems shall monitor for water flow and sprinkler supervisory signals via an approved fire alarm panel to central station. One smoke detector shall be located over the panel, a manual pull station located at the front door, and an audible water flow alarm provided. A separate Fire Alarm Permit is required from a certified fire alarm company. This review does not include approval of system design or installation.</li> <li>3) A sprinkler supervisory system shall be provided in accordance with NFPA 101, Life Safety Code, and NFPA 72, National Fire Alarm and Signaling Code.</li> <li>4) Sprinkler system installation shall comply with NFPA 13R.</li> <li>5) A Knox Box is required.</li> <li>6) All construction shall comply with City Code, Chapter 10.</li> <li>7) All construction shall comply with 2009 NFPA 101, Chapter 30 New Apartment Buildings.</li> <li>8) All construction shall comply with 2009 NFPA 1, Fire Code. Review and approval by the AHJ shall not relieve the applicant of the responsibility of compliance with this Code (Chapter 1.14.4).</li> </ol>
