Raymond -

The intent of my email was to try to resolve the issue of an existing room in the basement that was converted to a bedroom with cooking equipment without a permit. There are building code and life safety code requirements that need to be met when a bedroom is added to a building. That is why you need to apply for the Commercial Interior Alteration permit to permit the bedroom after the fact, so the City can make sure that room is meeting the code requirements.

The Notice of Violation was issued on 2/15/18. Within thirty days of the notice, the property is supposed to be brought into compliance. I spoke to Oscar on the telephone on March 1, 2018. One of the things that he pointed out was the need for a staff member to be at the Inn at night. By applying for the Commercial Interior Alteration Permit, to make the bedroom in the basement legal, you will be addressing that need.

Raymond -

I'm sorry to hear about Oscar's mother.

Jason Grant, code enforcement officer and life-safety plan reviewer, is inspecting the building this afternoon to check that all the life safety code violations have been addressed. I asked him to check the sleeping room to see if it meets the life safety code. If it does, then a staff member may still sleep thee temporarily until Oscar is back from the Netherlands and he has time to make a decision about the room.

I apologize for any misunderstanding about addressing the use of the room. If it is going to continued to be used as a bedroom for the overnight staff then the Commercial Interior Alteration permit will need to be applied for to establish the use a bedroom where both the building code and life safety code are met. If Oscar decides not to continue to use the room as bedroom, then it can be converted back to its previous use or as a use where people are not sleeping there. It does not need to be physically removed.
