As requested, BSDA performed the structural assessment of an existing penthouse wall, which will be used to support pipe mountea antennas. After careful analysis, we concluded the antennas can be attached to the penthouse façade as per the construction drawings p-ov ded. The proposed installation has been designed in accordance with all applicable codes inducing the IBC 2003 and EIA TIA-G for antenna structures.

BSDA has reviewed the existing building structure and conc'uded that the new antennas can be placed with no modification to the existing structure. These loads are minimal and the impact to the structure is insignificant.
