this is paul Michael barry tenant at 96 winter st. #4.

I have had no hot water all weekend during christmas and most of last week, also the heat only comes on once a day around 5pm leaving me to freeze in my apartment for more than 20 hours a day. the hallway is 50 times warmer than in my apartment im tired of this and you have continuously violated my rights as a human being and tenant not to mention the laws for the state of maine I am supposed to have hot water to bathe and it is supposed to remain atleast 68 degrees inside as dictated by the laws for the state of maine. this has been an ongoing problem all winter. if you think you are going to freeze me out, or make it impossible for me to shower and do dishes without water / think again. your manager told me to move out if I didn't like it. she also made it clear that I should have never moved into this apartment. I am tired of this shit. I will be filing a civil lawsuit against you, the owner, and the former management company next week in superior court in Portland maine next week for compensation of mental and emotional distress, violating my rights as a tenant and breaking the law.

also the tiles that Michael brought to me were not enough to cover the whole kitchen floor and they do not stick to the floor, as no spray adhesive was supplied and is needed.

ALSO I HAVE BEEN THREATENED AGAIN BY THIS MANAGEMENT COMPANY WHICH IS A CLEAR BREAKING OF LAW. IT IS NOT MY RESPONSIBILITY TO WATCH OVER - CONTROL, OR ANY OTHER FORM OF POLICE-ING THE OTHER TENANTS IN THE BUILDING. IF YOU HAVE A PROBLEM WITH OTHER TENANTS NOT USING THE PROPER TRASH BAGS TO DISPOSE OF TRASH IT IS NOT MY JOB TO WATCH THEM TO SEE WHOM IT IS. PERIOD.... THE OTHER TENANTS ARE NOT MY RESPONSIBILITY ITS YOURS. AND IF YOU THINK THAT BY YOUR THREATENING TO CHARGE ME AND ALL OTHER TENANTS THE FINE FROM THE CITY THINK AGAIN .AS YOUR THREATENING LETTER STATES. WRONG. I HAVE THE LETTER. IF YOU CANT DO YOUR JOB BY THE LETTER OF THE LAW AND SIMPLE HUMAN QUALITIES THEN YOU SHOULD BE FIRED OR GET ANOTHER JOB. I HAVE BEEN TORTURED, ABUSED, AND THREATENED BY YOU AND THE LAST MANAGEMENT CO. I WILL NOT TOLERATE THIS ANY LONGER, I WILL BE USING \$150.00 FROM JANUARY'S RENT TO FILE MY LAWSUIT IN STATE COURT NEXT WEEK, AND I WILL BE WITHOLDING MY PORTION OF THE RENT UNTILL YOU FIX THESE PROBLEMS, HEAT HOT WATER ECT, AND I DONT MEAN FIX THEM FOR A COUPLE DAYS, OR GIVE HEAT FOR JUST ONCE A DAY
