Please see the attached responses:

- 1.) The occupant load of Joe's Super Variety is 70 unchanged from before
- 2.) Please see the Basement Plan A1-0
- 3.) These have not changed per your review during the Base Building Permit, which we addressed during that review, please see item # 3 in the attached memo dated 5/13/16.
- 4.) The mop sink is shown as item 'N' in the women's bathroom, we reviewed this location with Danielle Davis and she said it was fine there (please see the email chain from her and I at the bottom of this email)
- 5.) Please see the attached ramp added notations on the plan A1-50, the ramp elevation change is 3" and it is 36" long so a 1:12 slope per ADA.

I am handling the plan review for Joe's Variety. Given the slight change in the floor plan from what was originally proposed, can you provide the following:

- 1. Occupant load for the revised floor plan.
- 2. Provide lower level floor plan as well as the first floor plan provided.
- 3. Per Figure 404.2.4.1 Maneuvering Clearances at Manual Swinging Doors and Gates, clarify if the maneuvering clearances and push/pull approaches are adequate
- 4. Label mop sink in the kitchen floor plan.
- 5. Provide the elevations at the top and bottom of ramp with verification that the ramp meets the requirements of Section 1010.2 Slope.
