

With the issuance of this permit, the owner, builder or their designee is required to provide adequate notice to the city of Portland Inspections Services for the following inspections. Appointments must be requested 48 to 72 hours in advance of the required inspection. The inspection date will need to be confirmed by this office.

- Please read the conditions of approval that is attached to this permit!! Contact this office if you have any questions.
- Permits expire in 6 months. If the project is not started or ceases for 6 months.
- If the inspection requirements are not followed as stated below additional fees may be incurred due to the issuance of a "Stop Work Order" and subsequent release to continue.

Zoning

- 1. ANY exterior work requires a separate review and approval thru Historic Preservation. This property is located within an Historic District.
- 2. Separate permits shall be required for any new signage.

Building

- 1. Application approval based upon information provided by applicant. Any deviation from approved plans requires separate review and approval prior to work.
- Permit approved based on the plans submitted and reviewed w/Lesee, with additional information as agreed on and as noted on plans. This includes the removal or permanently fixed stop to prohibit the in-swinging doors from operating.
- 3. This is a Change of Use ONLY permit. It does NOT authorize any construction activities.
- 4. Separate permits are required for any electrical, plumbing, sprinkler, fire alarm, HVAC systems, heating appliances, including pellet/wood stoves, commercial hood exhaust systems and fuel tanks. Separate plans may need to be submitted for approval as a part of this process.

Fire

- 1. All construction shall comply with City Code Chapter 10.
- 2. Emergency lights and exit signs are required. Emergency lights and exit signs are required to be labeled in relation to the panel and circuit and on the same circuit as the lighting for the area they serve.
- 3. Fire extinguishers are required. Installation per NFPA 10.
- The Fire alarm and Sprinkler systems shall be reviewed by a licensed contractor[s] for code compliance. Compliance letters
- 5. are required
- 6. A separate Fire Alarm Permit is required for new systems; or for work effecting more than 5 fire alarm devices; or replacement of a fire alarm panel with a different model.
- 7. Any cutting and welding done will require a Hot Work Permit from Fire Department.




