## Good morning Andy,

The Inspections Division has received your permit application. We have performed a preliminary completeness check of your documents.

To complete your application, please submit the following plans:

- 1. Key plan showing the location of the area(s) of renovation within the total building footprint and adjacent tenant uses.
- 2. Life Safety Plan drawn to scale, showing egress capacity, any egress windows, occupancy load, travel distances, common path distance, dead end corridor length, separation of exits, illumination and marking of exits, portables fire extinguishers, fire separations and any fire alarm or fire sprinklers systems.
- 3. Please sign page 2 of the enclosed Building Permit application and return it to me.
- 4. We generally require plans stamped by a licensed architect or engineer. I am processing your unstamped plans, however there is a chance that the reviewer may request stamped plans.

## ..."Regarding Comment 2:

Life Safety Plan drawn to scale, showing egress capacity, any egress windows, occupancy load, travel distances, common path distance, dead end corridor length, separation of exits, illumination and marking of exits, portables fire extinguishers, fire separations and any fire alarm or fire sprinklers systems.

In discussing with Scott, this seems unnecessary for renovation of this scope. We aren't proposing any change to occupancy, egress paths, travel distances, etc. In looking at Phase II documents, no life safety plan was included. We have added a note to the cover sheet indicating that there are no life safety impacts..."
