

SHORT FORM WARRANTY DEED

Casimara A. McIntire, of Skillings Street, South Portland, Maine ("Grantor"), FOR CONSIDERATION PAID, grants to East End Holdings, L.L.C., a Maine limited liability company with a mailing address of 1 Carroll Street, Portland, Maine 04102 ("Grantee"), with WARRANTY COVENANTS, certain real property, together with any improvements thereon located in the City of Portland, Cumberland County, Maine and more particularly described as follows:

Beginning at the northeasterly bounds of Congress Street at a point one hundred sixty-eight and one-tenth (168.1) feet southeasterly from a stone monument at the easterly corner of Deering Avenue (formerly Grove Street) and Congress Street; and then running northeasterly and at right angles with said Congress Street by the southeasterly bounds of land now or formerly owned by Amanda M. Waldron, one hundred twenty (120) feet; thence southeasterly at right angles with the last mentioned line, forty-five (45) feet; thence southwesterly by a line parallel with the first mentioned line one hundred twenty (120) feet to said Congress Street; thence northwesterly by said southeasterly line of Congress Street forty-five (45) feet to the point of beginning.

This property is subject to all covenants, conditions, restrictions and easements of record, to the extent they apply to the property herein conveyed, and real estate taxes assessed but not yet due which the Grantee, by acceptance of this deed, agrees to assume and pay.

Being the same premises conveyed to Merton N. McIntire and Casimara A. McIntire by deed from Frank S. Rand and Emily S. Rand dated January 19, 1968 and recorded in the Cumberland County Registry of Deeds in Book 3027, Page 463. Merton N. McIntire died May 22, 1996 leaving Casimara A. McIntire as surviving joint tenant.
