Hi Jeanie,

Tyler has been in touch with you about the Bramhall, but he was busy right now, so I'm forwarding on the information. Here are a couple attachments that illustrate some of your questions. And I'll try to give you a brief answer of your questions via email.

- 1) I have attached a plan for where all the bar fixture and equipment will be. I have a call into Mike, and am awaiting his return call. He or one of his associates have been in the building before. Is there a way to get a building permit with one of the conditions that Mike will sign off on everything before we get out COE? I'm just trying to expedite here, (as I know you hear this all the time), but I'm starting to get under the crunch here. I started submitting back in February, and I'm 4 months in without being able to touch anything, it's really, really starting to hurt me.
- 2) In our original plans, we had hoped to move them, but we are not now, so the plans now reflect what the current layout is, there will be no changes to the bathroom layout/fixtures.
- 3) We had hoped to do a radiant floor, we are not. The concrete floor will simply be "polished / sanded" and refinished. There will be no changes in the height or additional concrete added.

Hi Tyler,

I reviewed the revisions for this permit and have a few comments:

1. Provide the bar fixture and equipment layout, and contact the Public Health Dept., Mike Russell, 756-8008 for confirmation of Food Code requirements, provide all revisions.
2. Clarify the existing bathroom layout, the new plan is not consistent with the previous plan if you are just replacing fixtures. It looks like the rooms are being reconfigured.

3. Clarify if the new concrete floor is being added where and how.
4. Provide a stair section showing the typical rise and tread profile and dimensions.
