

- Issues: ① Does ~~any~~ ^{use} of four properties constitute a sheltered care group home?
- ② Is 38 Deering Street a single family home?

Findings of Fact and Conclusions of Law:

The Board's authority to review an interpretation of the building authority is pursuant to Section 14-472 of the land use code. Applicant maintains 38 Deering St. is not a single family dwelling, and that the four properties are sheltered care group homes. The applicant is seeking a review of the determination of the Zoning Administrator in an October 18, 2012 letter that the properties owned by several entities, at 38 Deering Street and 40 Deering Street meet the definition of single family dwelling, and do not meet the definition of 'sheltered care group home(s)'. The applicant includes in his appeal two other properties, 43 Melien Street and 235 State Street, which the Zoning Administrator did not specifically mention in her letter of October 18, 2012, but which are also operated by PK Holdings Inc, d/b/a Foundation House.

Section 14-47 defines a sheltered care group home as "a facility which, in addition to providing food and shelter to a defined population, provides guidance or counseling services. Such services are a primary function of the facility."

That same section also defines these terms:

Dwelling: A building or portion thereof used exclusively for residential occupancy, including single-family, two-family and multifamily dwellings, but not including hotels, lodging houses, sheltered care group homes or tourist homes.

Dwelling, one-family: A detached building used exclusively for occupancy by one (1) family.

Family: Not more than sixteen (16) individuals living together in a dwelling unit as a single nonprofit housekeeping unit. A group occupying a hotel, fraternity house or sorority house shall not be considered as a family. The family may include necessary servants.

The Board heard testimony from Mr Babcock that the property at 38 Deering St. is a single family dwelling. The Board finds 38 Deering Street is a single family dwelling. ~~There was~~ No evidence was presented that 38 Deering is. The Board heard testimony that none of the four properties listed above, operated or owned indivisibly by the Babcocks, as do not have food served other than by the residents therein;



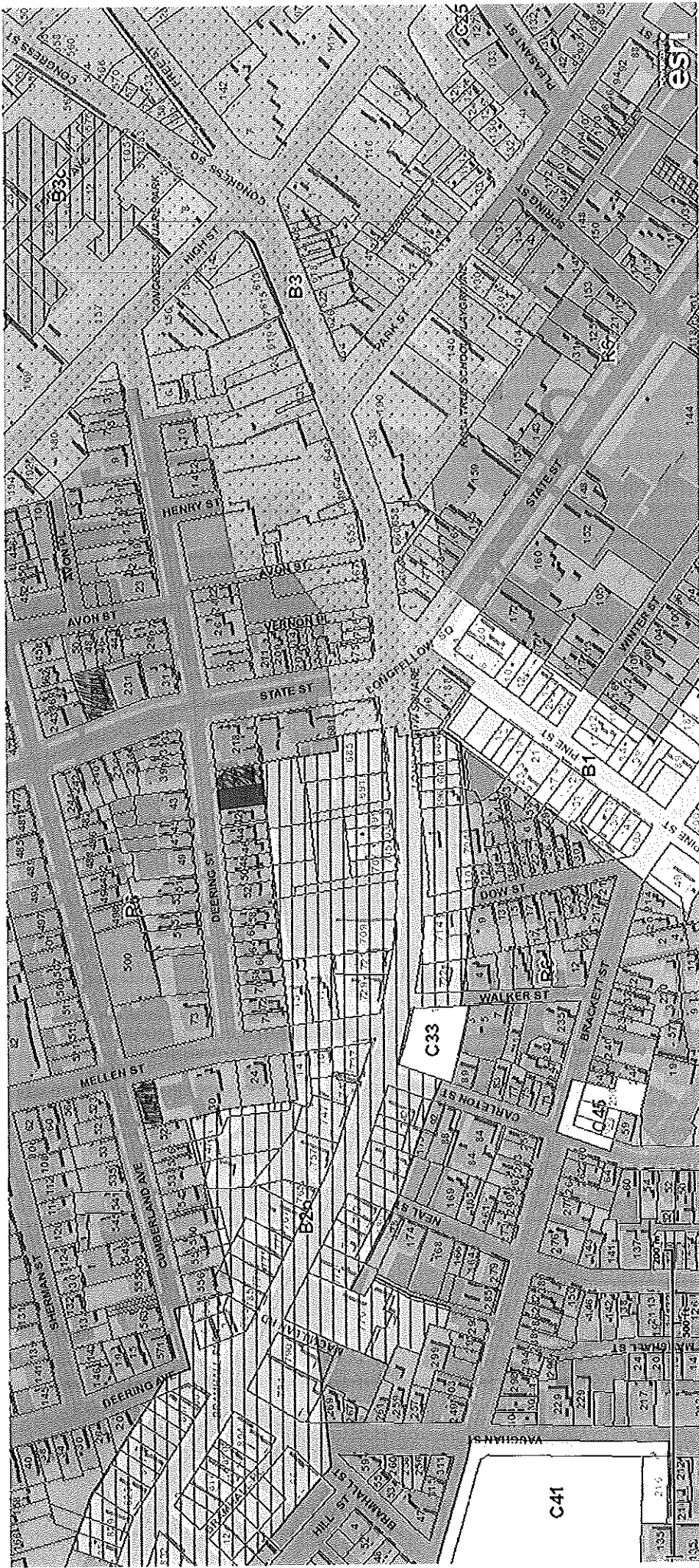

SUBJECT: INTERPRETATION OF SHELTERED CARE GROUP HOME

DATE: NOVEMBER 29, 2012

This memo is to further explain my determination letter dated October 18, 2012. It is important to have the Land Use Ordinance definitions available for reference.

Sheltered care group home: A facility which, in addition to providing food and shelter to a defined population, provides guidance or counseling services. Such services are a primary function of the facility. (section 14-47 definition)

Sheltered care group homes, as defined in section 14-47 of this article, for up to twelve (12) individuals, plus staff, and serving a primary population which is not handicapped persons, parolees, persons involved in correctional prerelease programs, or current illegal drug users, (from section 14-137(a)2 of the R-6 conditional zone allowance).

Handicapped person: A person with physical or mental impairment which substantially limits one (1) or more of such person's major life activities, a person with a record of having such an impairment, or a person who is regarded as having such an impairment. This term does not include current, illegal use of or addiction to a controlled substance as defined in 21 U.S.C. section 802. (section 14-47 definition)

Handicapped family unit: A dwelling which provides living facilities for handicapped persons. A handicapped family unit may also provide counseling and support services. Staff members may also be included in the population. (section 14-47 definition)

Please be aware that all the properties in discussion of "Foundation House" properties are located in the R-6 residential zone. The properties in discussion of Foundation House properties are under different ownerships.

I determined in my October 18, 2012 memo that the properties known as Foundation House properties do not meet the definition of a sheltered care group home. My determination looked at the activities that are occurring on the specific properties and not what the Foundation House programs offer at other sites outside of the R-6 zone and outside of the properties referenced. Based upon the section 14-47 definition food is not being provided on site. Each occupant provides their own meals. The occupants are

required to provide their own rents for living on the property. The definition regards providing guidance or counseling services as a *primary* function for a sheltered care group home facility. The Foundation House properties do not have any guidance or counseling services on site.

Within the R-6 zone under section 14-137(a)2 it states that a sheltered care group home does not include primary populations that are defined as handicapped persons, parolees, persons involved in correctional prerelease programs, or current illegal drug users.

Under section 14-47 a handicap person is defined as “[a] person with physical or mental impairment which substantially limits one (1) or more of the person’s major life activities, a person with a record of having such an impairment, or a person who is regarded as having such an impairment. This term does not include current illegal use of or addiction to a controlled substance as defined in 21 U.S.C. section 802. This definition is almost identical to the definition of disability under the Maine Human Rights Act (the “Act”). See 5 M.R.S.A. section 4553-A(1)(A) (defining a disability as, among other things, “[a] physical or mental impairment that substantially limits one or more of a person’s major life activities...”). In fact, under the Act, alcoholism is specifically listed as a recognized physical and/or mental disability. See 5M.R.S.A. section 4453-A(1)(B). Finally, it is important to note that the City has previously attempted to limit the number of pre-release facilities within the City (due to a perception that surrounding municipalities were not accepting into their respective communities their fair share of said facilities) and the Maine Superior Court found this limitation within the zoning ordinance was unconstitutional. See Halfway house, Inc. d/b/a Pharos House v. City of Portland, 1996 Me. Super. LEXIS 127. The court also required the City to pay the plaintiff’s attorney’s fees in the case.

Therefore the Foundation House program does not constitute a sheltered care group home by definition, and there are no requirements for such properties to abide by a 500’ distance between each property.

Hi David,

I am responding to your original request to re-analyze the uses for Foundation House in or around Deering Street. On October 17th I met with Danika and Patrick Babcock to discuss how they used their buildings that they own. I am attaching a copy of GIS map indicating the location of those properties. All properties are in the R-6 multi-family residential zone. My focus was on the definition of a *Sheltered care group home*:

"A facility which, in addition to providing food and shelter to a defined population, provides guidance or counseling services. Such services are a primary function of the facility".

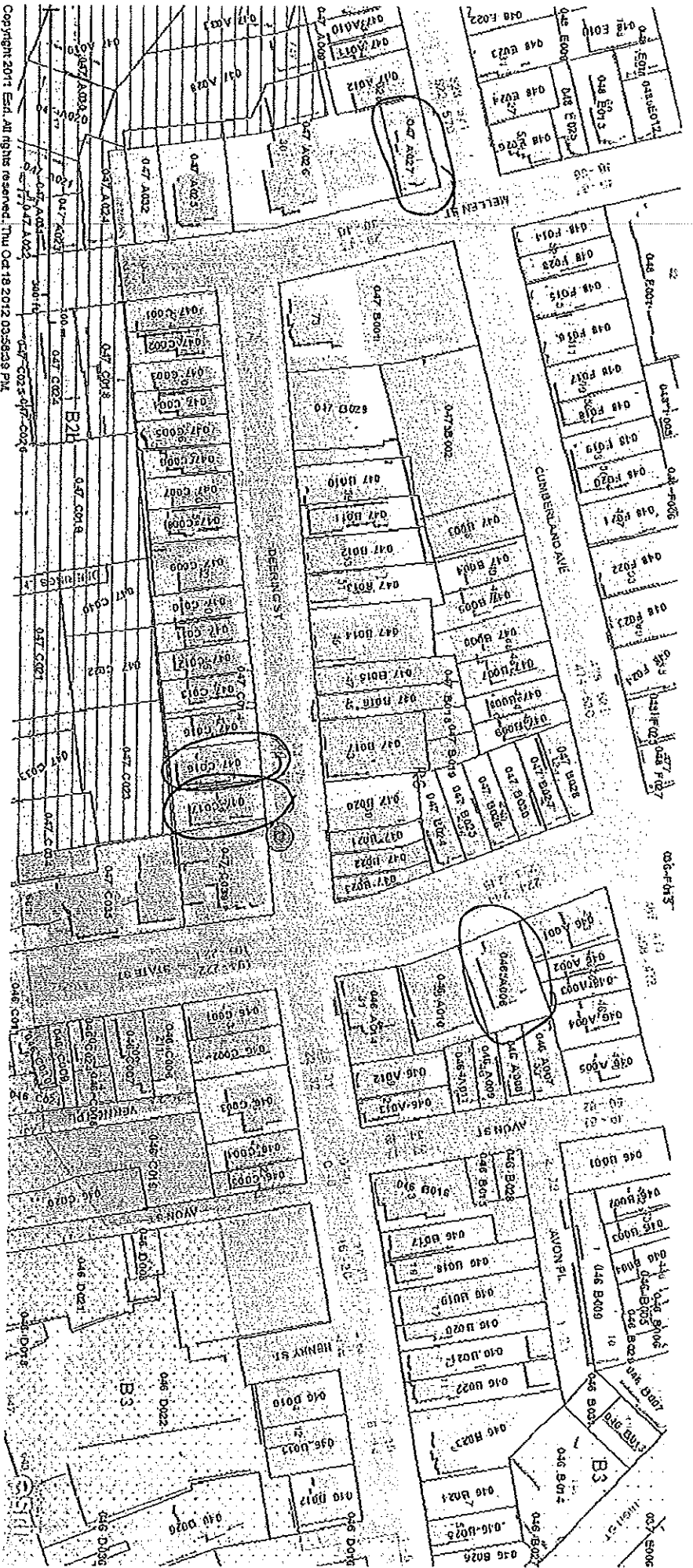
First, the Foundation properties charge rent. Secondly, food is not provided. Everyone provides their own meals. So the first criteria of providing food and shelter has not been met. The definition goes on to say that guidance or counseling services are a primary function of the facility. I did not find that any of the properties had any significant counseling or formal guidance on-site. All such counseling and guidance is off-site near by in the B-3 business zone. The Foundation leases several suites on the third floor of the State Theater building on Congress Street. I visited the site for a firsthand look. So I have concluded that none of the four properties could meet the definition of a "sheltered care group home".

Further discussions lead me to believe that 38 Deering Street is still functioning as a single family dwelling. The Foundation does use that address as a mailing address for their business. I discussed home occupation requirements with them concerning their use at that location. I am currently not convinced that it is a major "business" site. And yes, they have lived in the building on occasion. And they still have their home in Cape Elizabeth. They own two homes. I find that no different from many people who own a home on the mainland and a home on one of the islands. I had further discussions concerning.

40 Deering Street which is legally considered to be a single family dwelling. I believe that property is now being use more like a lodging house. Currently the Babcocks are working with an architect, Will Winkleman, for some interior alterations to the building. I will be meeting with Will Winkleman to go over his plans. I am encouraging the owners to apply for a change of use permit to legalize the use to a lodging house, a permitted listed use in the R-6 zone. There are other criteria for a lodging house that the applicant must meet. That is where the architect comes in. I will be meeting with the architect within the next two weeks. I can update you at that time as to the status of this property.
