Hi Ann,

We recently purchased 24 units located in 4 buildings on Grant Street and are seeking a bank loan post-purchase. We expect banks will request evidence of number of dwelling units and no outstanding violations. I'm hoping you can write me a letter. I attached the standard letter; you might have to change it a little because it's 4 buildings.

Also, the Assessor page just lists two buildings: 65 Grant Street, 048 B016001; I believe this is representing 61, 63 and 65 Grant Street (3 buildings of 6 units each for a total of 18 units); it looks as if these 3 were built together as a small complex, but they are 3 distinct buildings. The other building listed on the Assessor page is 69 Grant Street, 04 B015001, which is the 4th six-unit building.

If it helps, attached is what I found on the microfiche that I found helpful:

61 Grant Street: 6 DU in 1982

61-67 Grant Street: C of O showing 18 apartment dwellings in 1977; this is presumably 6 apts each at 61, 63 and 65/67

Grant respectively

63 Grant Street: 6 DU in 1982

65/67 Grant Street: 6 DU in 1990

As far as violations, last time I looked, there were some outstanding violations at 65 Grant: one on 8/4/2015 saying the fire escape was not structurally sound, and I did not see any follow up. Repairing that fire escape is on my list of capital

improvements. There's also one dated 8-7-2015 for missing smoke and CO alarms, and one on 9-10-15 for fire doors. Installing proper smoke & combo smoke/CO detectors and installing fire doors where they are not already is on our list of planed capital improvements. I did not see any outstanding violations at any of the other 3 buildings.

Referred to docs are attached. Let me know if you need more info. Once I have an invoice, I can swing a check down. Hope you are having a good summer so far. Thanks in advance for your help.
