PARCEL ONE:

A certain lot or parcel of land with the buildings thereon, located on the northerly side of Sherman Street in said Portland, bounded and described as follows: Beginning at a point on the northerly sideline of Sherman Street distant westerly along said northerly sideline of Sherman Street 350 feet from the northwesterly corner of Sherman and Mellen Streets; thence northerly and making an angle of 90° with said northerly sideline of Sherman Street a distance of 95 feet to a point; thence westerly and making an angle of 90° with last described course a distance of 50 feet to a point; thence southerly and making an angle of 90° with the last described course a distance of 95 feet to a point on the northerly side line of Sherman Street; thence easterly along the northerly sideline of Sherman Street and making an angle of 90° with last described course a distance of 50 feet to the point of beginning, containing 4,750 square feet, being numbered 127-129 Sherman Street and also being Lot No. 8, Block O.
