Per our conversation this morning, please provide the following information:

- 1. Provide layout of existing stairs and landing with dimensions. (I understand that these have been removed but I will need approximate dimensions).
- 2. Provide layout of proposed stairs (on separate plans) with complete dimensions of both landings, width of stair, exact location and dimensions of bay window, and clarify the width of the stairs where the stairs meet the bay window.
- 3. Provide frost protection as required. The existing footprint is smaller than the proposed footprint. Cleary show frost protection as required.
- 4. Provide opening limitations of the guardrail.

5. Provide attachment detail of the proposed stairs and landings to the existing structure.
