Per your request I've assembled paperwork on the fire doors on the interior of my building located at 56 Mellen Street. I had a fire inspection in 2001 which resulted in a request from the fire department to install fire doors leading into the apartments. I did this over a few years, some in 2002 and some in 2004. Then more recently after the fire inspection in November of 2008 related to legalization of the non-conforming unit, I replaced the door leading from the basement apartment into the unfinished part of the basement per Ben Wallace's request.

Attached are receipts and invoices related to the work done in 2002, 2004 and 2008. I also included some of the manufacturer information. All doors that I purchased/installed are 90 minute fire-rated.

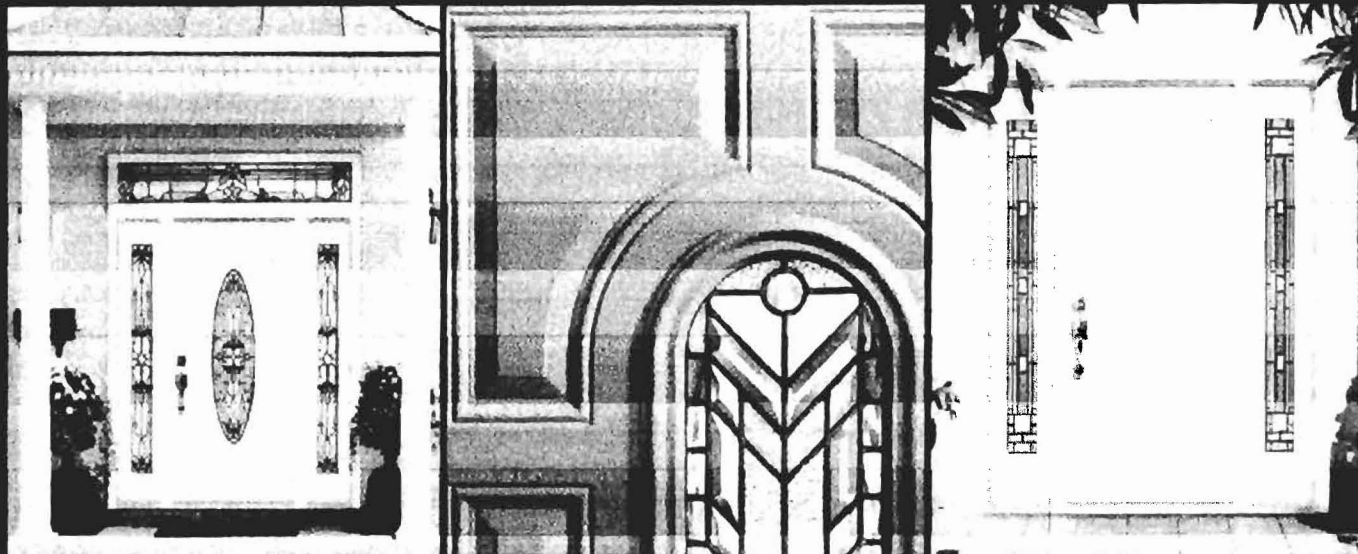
