 Today we did a routine inspection of this address. This building was last inspected in 2004 and violations written up at that time were not repaired by the re-inspection date. Today most of those items are still not repaired and appear to be worse. Most if not all the smoke detectors are missing or are chirping. This includes unit and hallway detectors. The basement door in the rear hall is either nailed or painted shut. There is a half door on side 1 which is open but the door in the hall is not fire rated. There are still holes in the hallways, storage in halls and debris in the basement. I did issue written warning letter for those items, but this building should probably be looked at by buildings. The father of a tenet on the first floor rear stated that his daughter has had problems with her stove and other items and the landlord will not return her calls. Lt Magnuson
