With the issuance of this permit, the owner, builder or their designee is required to provide adequate notice to the city of Portland Inspections Services for the following inspections. Appointments must be requested 48 to 72 hours in advance of the required inspection. The inspection date will need to be confirmed by this office.

- **Please read the conditions of approval that is attached to this permit!! Contact this office if you have any questions.**
- **Permits expire in 6 months. If the project is not started or ceases for 6 months.**
- **If the inspection requirements are not followed as stated below additional fees may be incurred due to the issuance of a "Stop Work Order" and subsequent release to continue.**
- **Per Section 107.3.1 of the Maine Uniform Building and Energy Code (MUBEC). One set of printed approved stamped construction documents shall be kept at the site of work and shall be open to inspection by building officials.**

It shall be the owner's responsibility to contact the Code Enforcement Officer and notify them of that specific date.

1) This permit is approved based upon information provided by the design professional. The design professional in responsible charge shall be responsible for reviewing and coordinating submittal documents prepared by others, including phased and deferred submittal items, for compatibility with the design of the building. Any deviation from the final approved plans requires separate review and approval prior to work.				
2) No permit shall be issued until the applicant has removed and disposed of all "friable asbestos" such material in accordance with applicable state and federal regulations.				
Utility connections. Service utility connections shall be discontinued and capped in accordance with the approved State and City or Portland rules and requirement.				
3) Sidewalk Closure Requirement: 3306.1 Protection required. Pedestrians shall be protected during construction, remodeling and demolition activities. Please contact the City's Public Services Department at 874-8822 for a sidewalk closure permit application, a sidewalk closure permit must be issued by the City prior to the start of any demolition work.				
4) Demolition permits are valid for a period of 30 days from the date of issuance. A written request must be submitted and granted for an extension to this time period. Dust prevention shall be controlled per Chapter 6 of the Municipal Ordinance and demolition per Section 3303 of the IBC 2009 (MUBEC).
