SECOND NOTICE OF VIOLATION

Exterior

Violation:

FOUND., CELLARS, EXTERIOR WALLS, ROOFS.; Every foundation, basement, cellar, exterior wall and roof shall be substantially weathertight, watertight and vermin-proof; shall be structurally sound and in good repair; and shall be safe for the intended use as well as capable of supporting whatever load normal use may cause to be placed thereon. Every exterior wall or portion thereof shall be painted or stained. Water from roofs shall be so drained and conveyed therefrom as not to cause repeatedly wet floors, walls or ceilings, or hazard to adjacent buildings or the occupants thereof.

Notes:

Immediately remove the piece of wood hanging off of the roof. Inspection of entire roof required, call 207-874-8703 to schedule the inspection. Note: Historic review/approval may be required.

Comments:

Piece of wood still hanging from roof of building. It is a public safety concern. Needs to be addresed ASAP.
