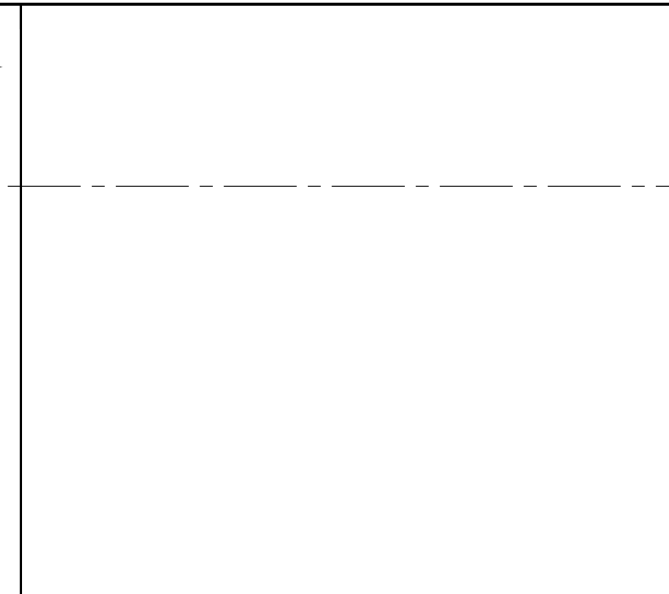
A1 PLAN DETAIL - SECOND LEVEL MEZZ. EL. 109.0'

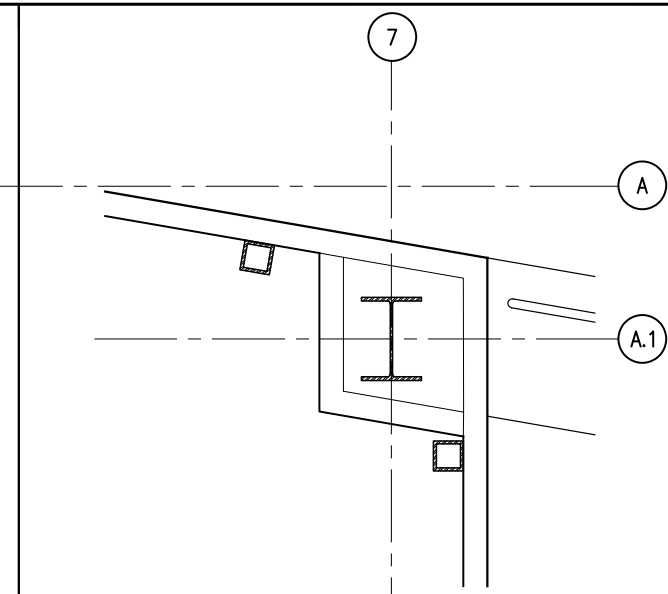
B1 PLAN DETAIL - SECOND LEVEL MEZZ. EL. 109.0'

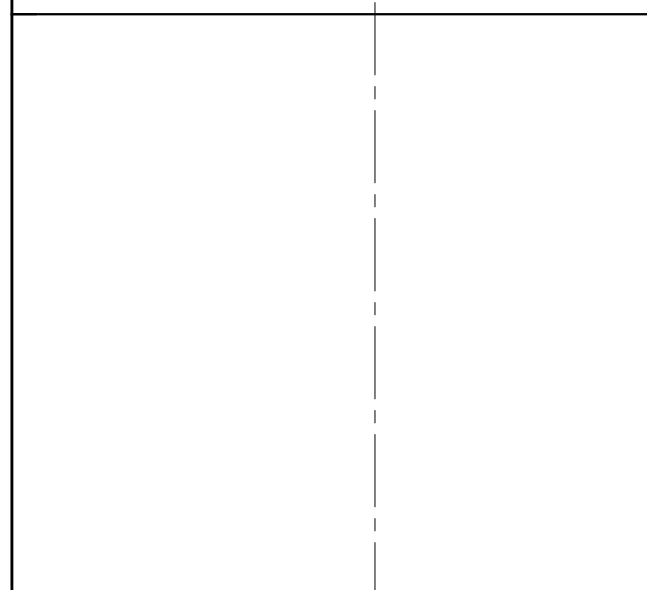
C1 PLAN DETAIL - SECOND LEVEL MEZZ. EL. 109.0'

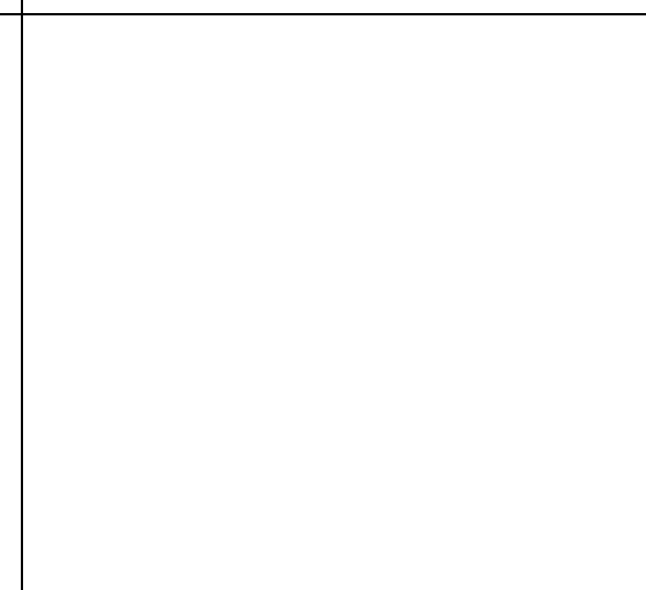

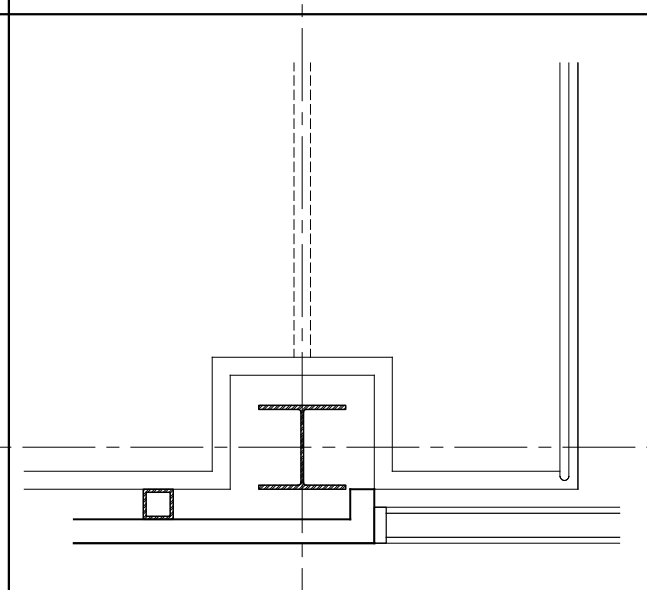

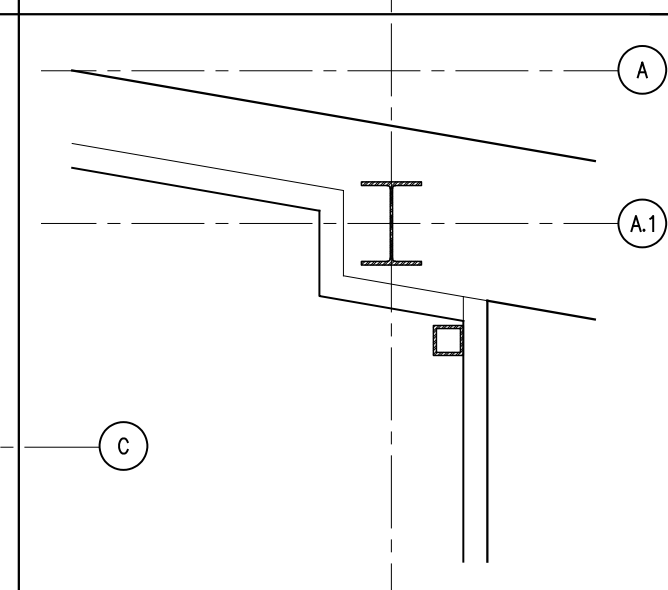
A3 PLAN DETAIL - SECOND LEVEL EL. 96.0'

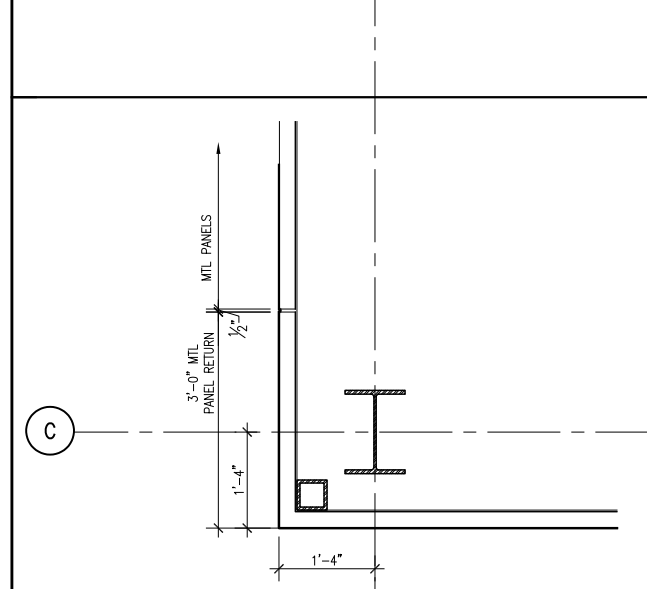
B2 PLAN DETAIL - SECOND LEVEL MEZZ. EL. 109.0'

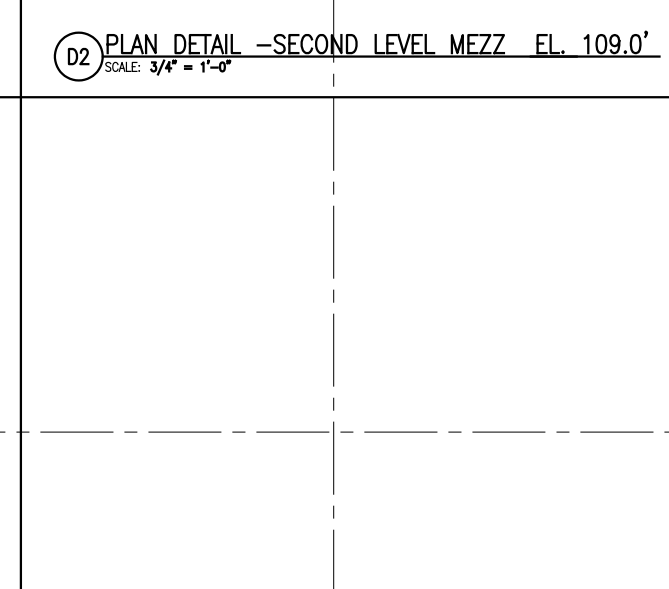
F2 PLAN DETAIL - SECOND LEVEL EL. 96.0'

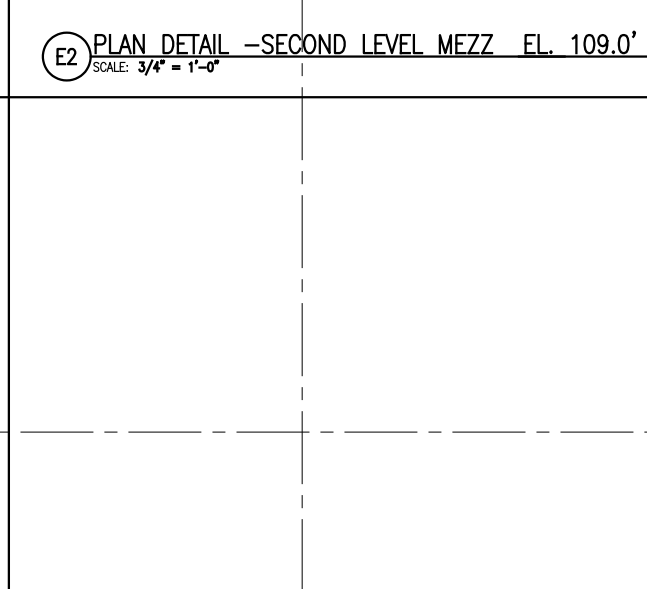

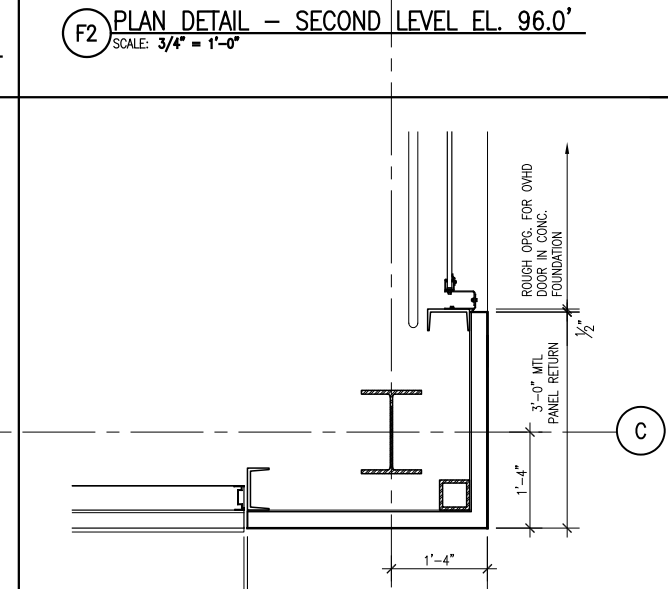
C4 PLAN DETAIL - FIRST LEVEL MEZZ. EL. 84.0'

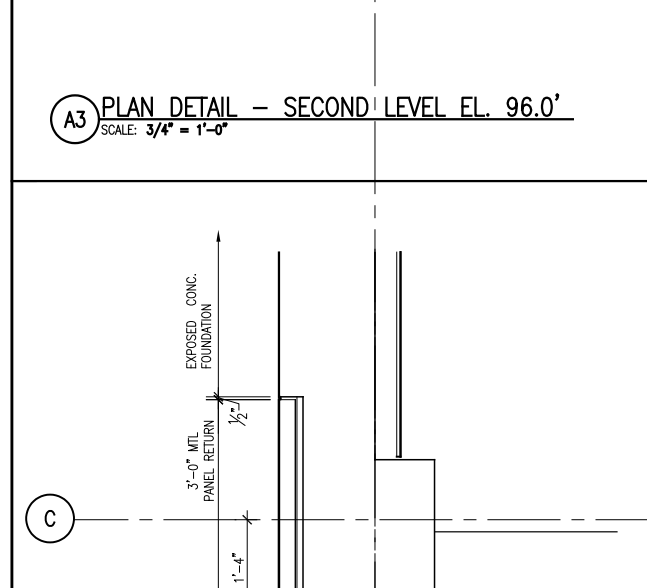
D2 PLAN DETAIL - FIRST LEVEL MEZZ. EL. 84.0'

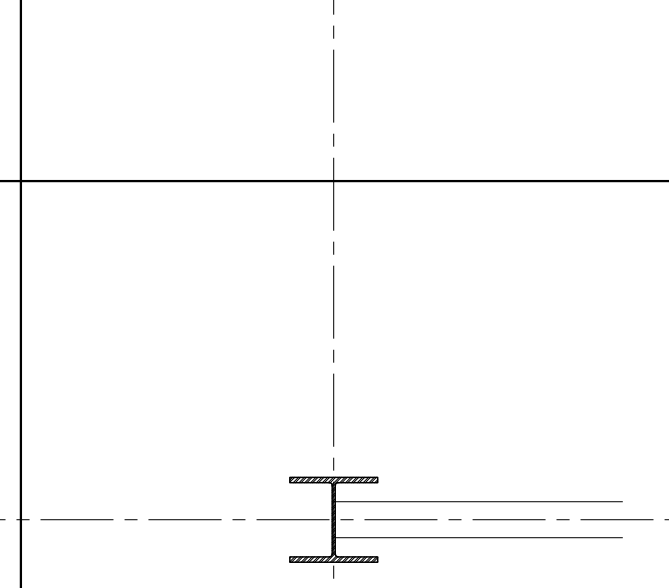
F3 PLAN DETAIL - SECOND LEVEL EL. 96.0'

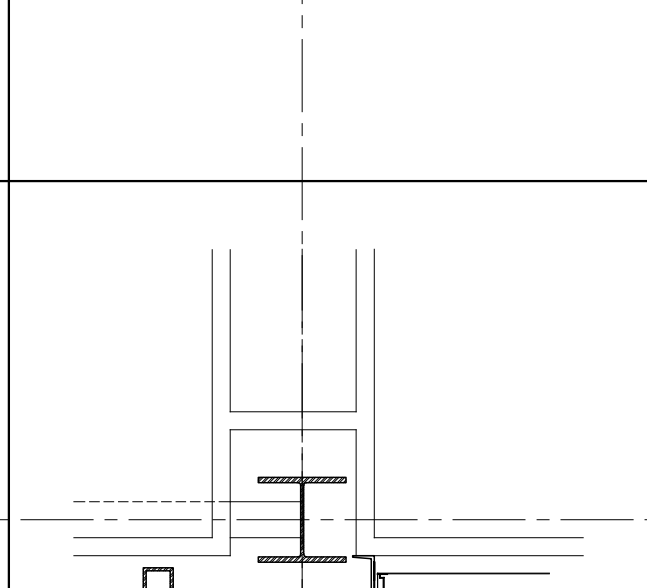

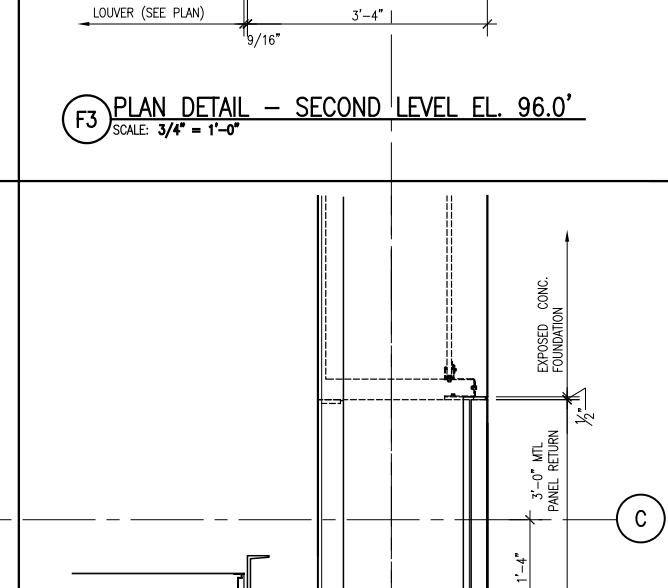
C5 PLAN DETAIL - FIRST LEVEL EL. 72.0'

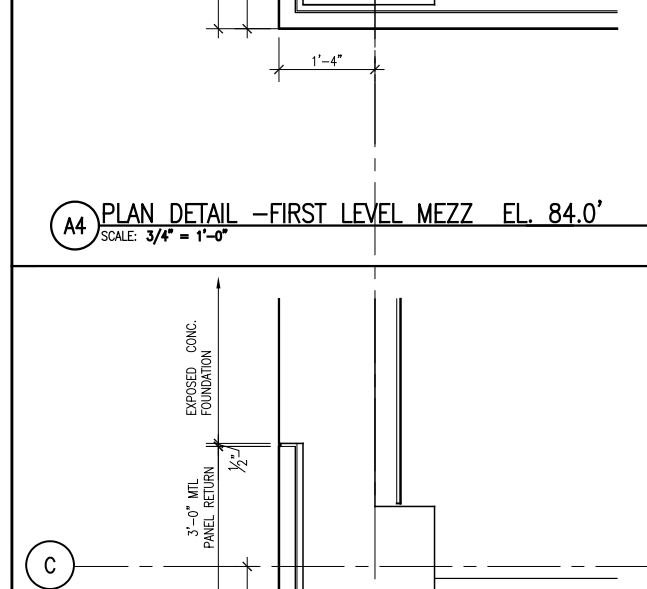
D4 PLAN DETAIL - FIRST LEVEL MEZZ. EL. 84.0'

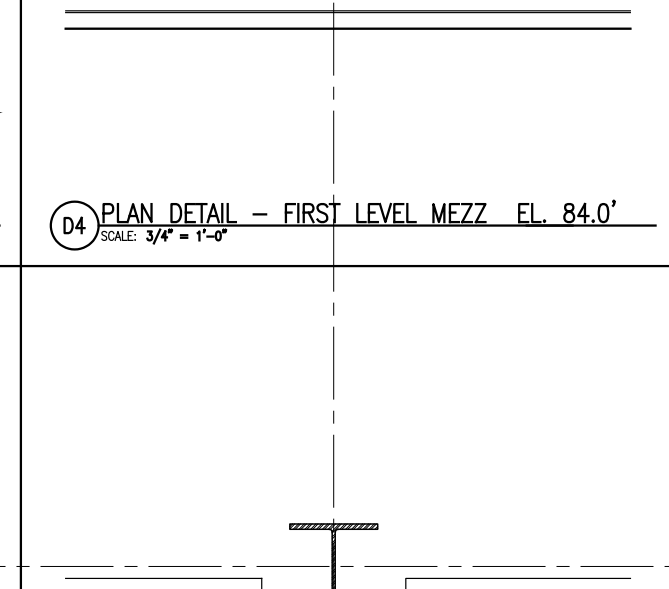

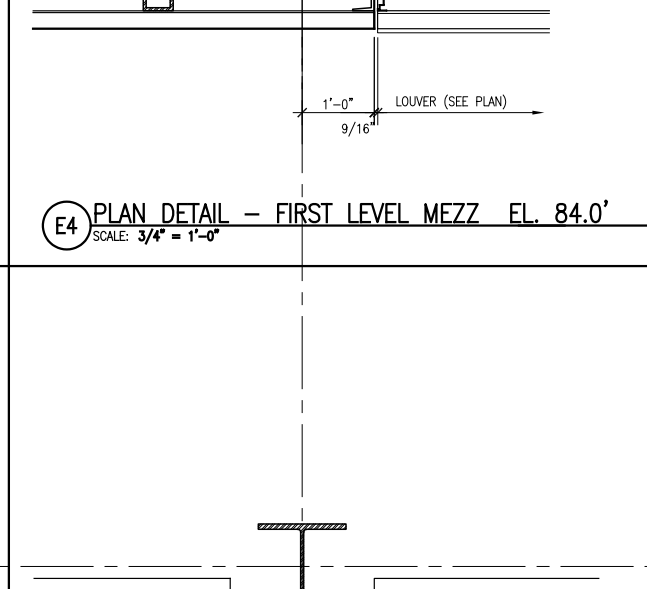

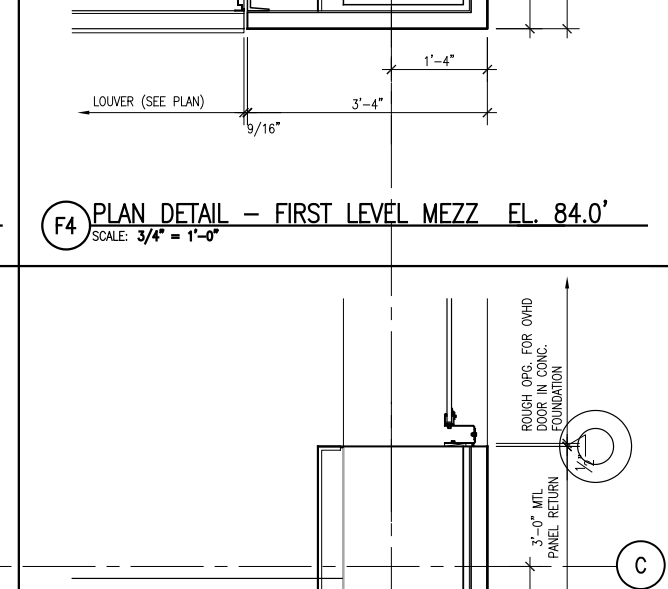
C6 PLAN DETAIL - FIRST LEVEL EL. 72.0'

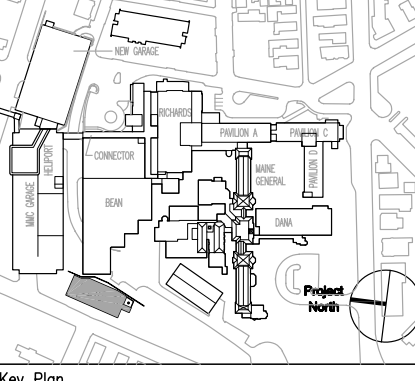
