The ACCU Relocation project consists of a total of 9,880 GSF clinical space renovation on levels 7<sup>th</sup>, 8<sup>th</sup>, and 9<sup>th</sup> of the Richards building at Maine Medical Center. The bulk of renovation work is located on level 8, where existing general administration space will be converted to 11 new ACCU Bays and supporting spaces.
